The Task Group conducted various conference calls and after corresponding *via* mail has drafted a Plan of Action for the conduct of PARAMARSH Activities in the session 2020-2021.

PLAN OF ACTION

- A. Identify the weaker NAAC criteria of Mentee Institutions by preparing questionnaires.
- B. Mailing the questionnaire to the Mentee Institutions.
- C. On receipt of the responses to the questionnaires, classify the requirements of the Mentee Institutions and respond to them as per requirement.
- D. Sharing online videos/ PowerPoint presentations, etc. of resource persons who have addressed the New NAAC Criteria based on the stage or progress of preparation of the Mentee Institutions.
- E. NAAC Criteria Specific Programs to be conducted by resource persons from DACN. (Involving teachers out of TASK GROUP too - either online or in person depending on the circumstances).
 - a. Workshop on NAAC related Data Management for IQAC Coordinators and Department Heads of Mentee Institution by IQAC of DACN
 - b. Workshop on Curriculum Planning, Implementation and Enrichment
 - c. Hands on Training of Learning Management System (LMS) and MOOCs.
 - d. Brainstorming activity on research topics at DACN and Collaboration with Mentee Institutes (Both will be benefited)
- F. Set Timeline for implementing each criteria in the mentee institution
- G. Evaluate the Outcome at the end of session 2020-21
- H. Periodical (every two months) feedback with photographic proof from time to time.
- I. Prepare a manual to guide the mentee institution (A manual can be created by IQAC of DACN to guide them all)
