

INSTRUCTIONS FOR FILLING APPLICATION FORM

1 A:

1. A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/ relevant/ allied subject from an Indian University, or an equivalent degree from an accredited foreign university

2. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET :

Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a. The Ph.D. degree of the candidate has been awarded in regular mode only;
- b. The Ph.D. thesis has been evaluated by at least two examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e. The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/ funded/supported by the UGC/ICSSR/CSIR or any similar agency.

Note:

1. *The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.*
2. NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

OR

1 B:

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- a. Quacquarelli Symonds (QS) ;
- b. The Times Higher Education (THE) or
- c. The Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

- 2. SSC marksheet, HSC marksheet, Graduation all Marksheets and Degree, Post Graduation all Marksheets and Degree, Ph.D. Degree, NET/SET/JRF certificate, Aadhar Card, copies to be submitted alongwith application.**

3. **Ph.D** candidates should submit Ph.D. equivalence certificate as per UGC regulation 2009 from respective university.
4. **Candidate** should also submit final year UG, PG marksheet verification certificate from respective university.
5. **Candidate** should also submit UG, PG, Ph.D. Degree verification certificate from respective university.
6. **Candidates** qualifying NET/SET examination should submit NET/SET verification certificate from competent authority.
7. **Candidates** belonging to reserve category should compulsorily submit Valid Caste Certificate and Caste Validity Certificate from competent authority.
8. **Candidates** belonging to VJ/NT, OBC and SBC category should compulsorily submit Valid Non-Creamy-layer Certificate from competent authority.
9. **Candidates claiming** EWS category should compulsorily submit Valid EWS Certificate from competent authority.
10. **Candidates** are required to submit their best 5 Published Research papers (Cover Page) only.
11. **Candidate** should **not submit** their conference attendance/ presentation Certificates.
12. **Candidate** are required to submit **single page** proof of their patents, monographs and books published.
13. **Candidate** should submit Government Gazette notification copy in case of change in name.
14. **Candidate** should submit experience certificate if applicable.
15. **No-objection Certificate** from present employer to be submitted if applicable.
16. **Postal order of Rs. 100/-** should be drawn in favor of “**Principal, Dr. Ambedkar College, Deekshabhoomi, Nagpur**” must be attached with the application.
17. Last date of receiving application is **Monday 24th April, 2023, 05.00 pm.**
18. **Candidates** are required to bring all original documents and proofs at the time of Interview for verification.
19. Application complete in all respect can be submitted in person/ by registered post on all working days during office time.
20. Incomplete application form shall be liable to be rejected.
