

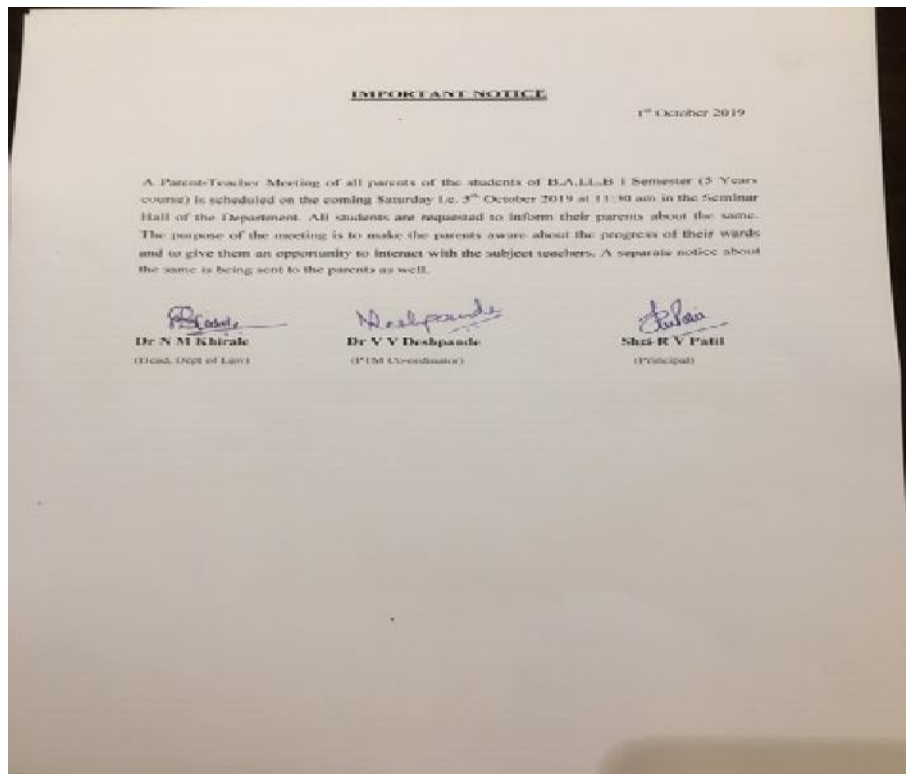

## **DETAILED REPORT**

A Parent-teacher meeting was organized in the Department of Law with the parents of B.A.LL.B I Sem (5 Yrs Course) students. The said meeting was held in the Seminar Hall of the Department of Law on the 5<sup>th</sup> October (Saturday) 2019.

The main purpose of the meeting was to inform the parents about certain key features of the institution, especially of the Department of Law. Also, through this meeting the College tried to supply a platform for the parents to have a one-to-one discussion with all the subject teachers and check the records and progress of their wards. Since the CET admission process was still on, parents of only those students were invited who were already enrolled into the institution.

The meeting began with a welcome address to the parents, which was delivered by the Head of the Department of Law DR N M Khirale. He welcomed the parents and thanked them for having found time out of their busy schedules to attend the said meeting. He also briefed the parents about the norms of discipline which the students are expected to follow. Dr Khirale's welcome address was then followed by a presentation by the PTM Co-ordinator Dr Varsha V Deshpande. She began her presentation by informing the parents about the A grade accreditation by NAAC, Bengaluru as well as the status of "College with Potential for Excellence" accorded by the UGC. Thereafter she exhaustively informed the parents about the Department of Law in general, its full-time teaching faculty members, non-teaching staff etc. She highlighted on the state-of-the-art infrastructure available in the Department like sufficient and well ventilated classrooms, an exclusive Law library, Moot court halls, auditorium, Computer labs etc. Parents were told about the Software databases available in the Department and they were urged to encourage their children to make use of these modern facilities. Thereafter Dr Deshpande informed the parents about the wide range of activities like debates, elocutions, drafting and essay writing, moot courts, client counseling and many others which are routinely hosted by the Department of Law. She pressed adequately on the importance of the students participation in such events which can cultivate the requisite soft-skills for their personality development. A great emphasis was placed on the importance of moot court competitions in law colleges. She gave a detailed explanation of how these competitions are hosted by the Department and why it is completely non-negotiable that students participate in this activity. She mentioned proudly to the parents that the first in-house Moot Court competition was hosted by the Department just a day before the PTM and which furnished the students of I semester with an opportunity to participate in the event just within 20 days of their joining the college. This, according to Dr Deshpande, was a phenomenal achievement for both, the students as well as the Department. Dr Deshpande also informed the parents about the merit students of the Department as well as alumni interactions with students.

After this presentation, Dr Hema V Menon, the IQAC Co-ordinator of the college and a senior teacher in the Department informed the parents about the use of Google Classroom which is routinely done by the teachers in the Department. Technology, she said, was put to optimum use to facilitate an enriched learning experience for the students. She also informed the parents about an active Students' Grievance Redressal Cell that is functional in the Department and encouraged the students and parents to make use of that cell for voicing their legitimate concerns and grievances.

The Principal of the College Shri R V Patil delivered the concluding remarks. He reposed faith in the competence of the faculty members of the Department and re-assured the parents that the Department would cater to the learning needs of their wards in a holistic and efficient manner. He urged the parents to respond with the same enthusiasm for all Parent-Teacher meetings and said that teachers and parents can collaborate in meaningful ways to design a brighter future for the students.

The Principal's address was followed by an interaction between parents and teachers with regard to choice of optional subjects, pattern of examination, award of internal marks etc.

All the full-time faculty members as well as the visiting faculty members were prominently present for the meeting.
