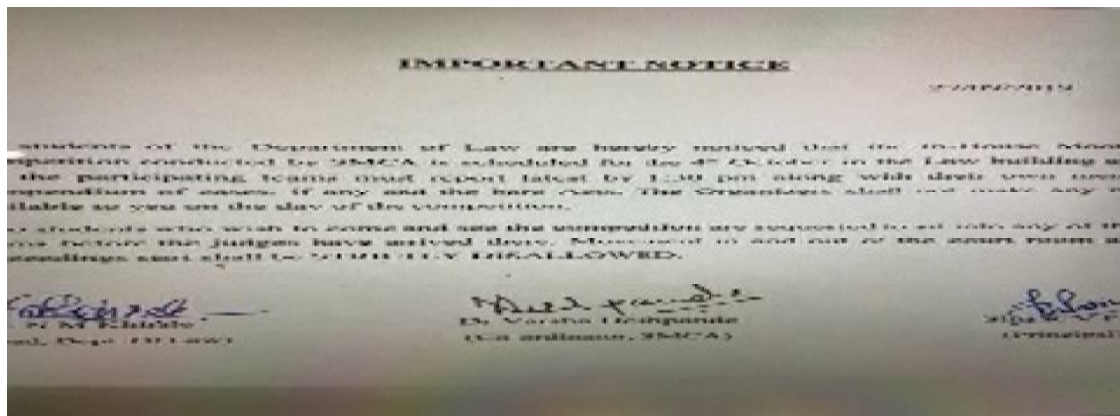

REPORT OF MOOT COURT COMPETITION BY SMCA:

On the 4th October 2019, Friday, the SMCA hosted an In-house Moot Court Competition for the students of the Department. This was done as a follow up activity after the Moot court Workshop was organized by the SMCA. A moot court problem was drafted by the students of the Department on a contemporary issue of rights of same sex association couples. Several legal and Constitutional issues were involved in the problem that was drafted. There were total 10 teams of students participating in the event, every team comprising of three participants, two speakers and one researcher. The students were given a detailed rule book for the competition specifying the rules for drafting of memorials as well as oral arguments before the court. An Orientation was held on the 3rd October at 2:00 pm in the Seminar Hall for draw of lots and for appraising the students of the rules. The memorials were also submitted by the students by 1st Oct 2019. There were five court rooms in which 10 teams of students were divided. The students were judged according to the standards of all national moot court competitions. They were judged cumulatively for their oral arguments, response to court questions, written memorials and court

mannerisms. A Semester I team comprising of Sumiti Oza, Akanksha Shendre and Soham Kathane won the first prize.
