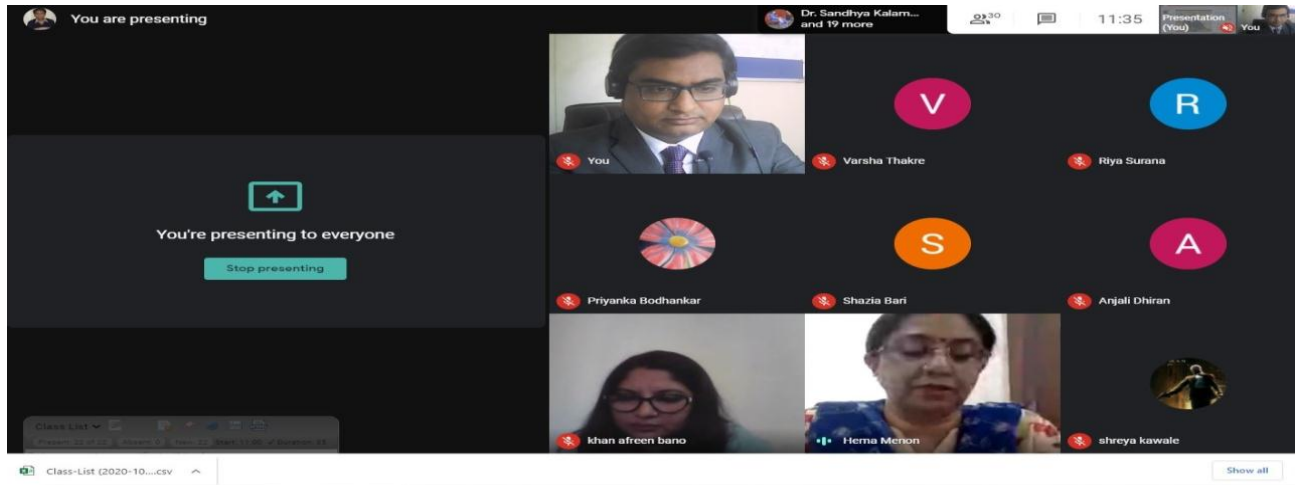
Dr. Ambedkar College, Deekshabhoomi, Nagpur, Department of Law organized a Guest lecture through online mode on the topic “Human Rights and the Right to Privacy: Where India stands in terms of International Law”. Adv. Afreen Khan, Advocate, Bombay High Court was the guest speaker for the program. The program commenced with a welcome address by Dr. H.V. Menon, Professor & Head, Department of Law, Dr. Ambedkar College, Deekshabhoomi, Nagpur. Adv. Afreen Khan, Advocate, Bombay High Court spoke about the right to dignity as a facet of Right to privacy. While making beginning remarks “Privacy is a privilege”, she also emphasized that in current age, the information can be misused. She further discussed that in the age of technical advancement, it is important to protect data as we share information with different online websites.

She also shed light on the need to have more stringent laws for data privacy as sometimes the information which is present in the public domain is misused. In today’s global economy, commerce has become online and thus, some measures should be taken to ensure to protect our data. She discussed various judicial decisions while delivering her lecture. She also spoke about Right to Information and also shared her own personal experiences regarding it. The lecture was then followed by Question – Answer Session.

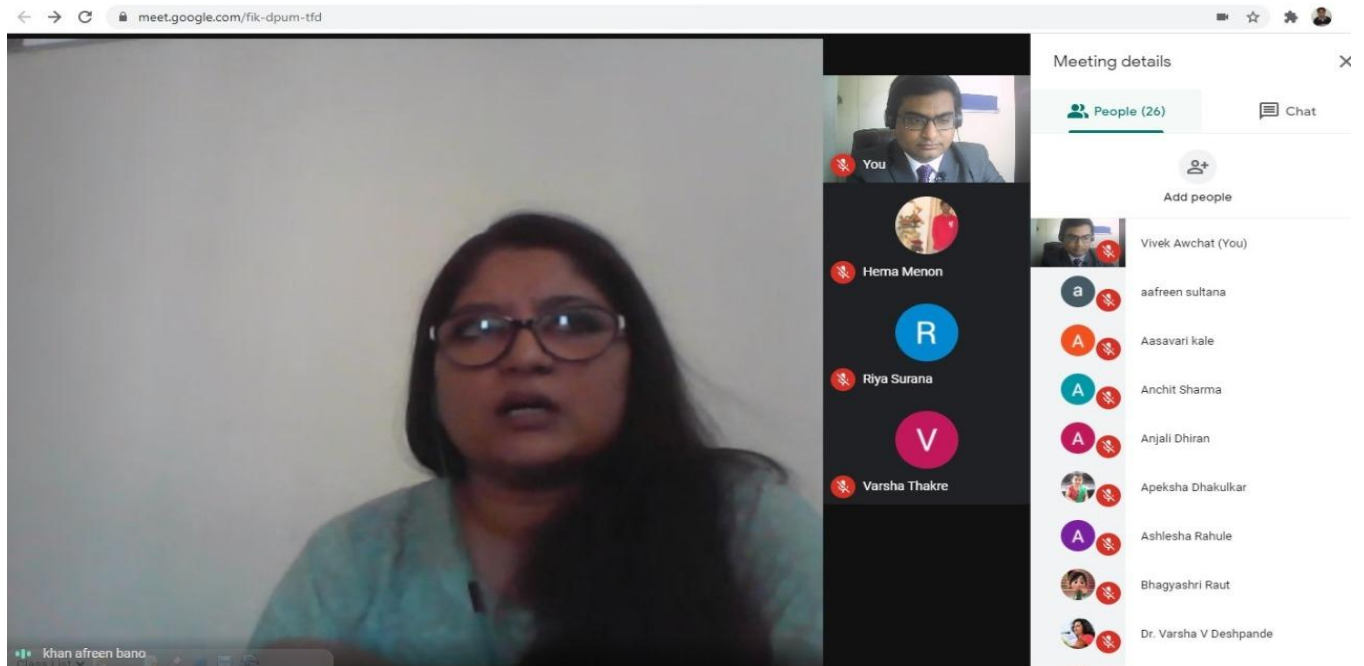

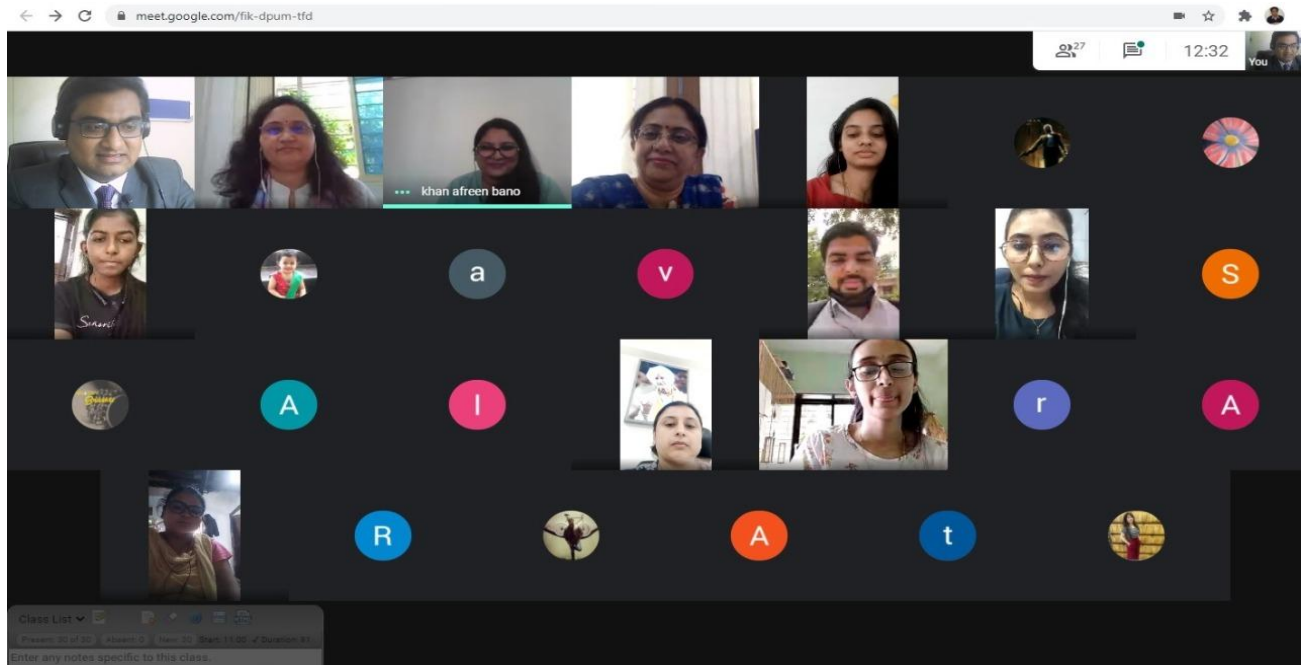
