REPORT ON GUEST LECTURE ON PROFESSIONAL ETHICS

Department of Law, Dr. Ambedkar College, Deekshabhoomi, Nagpur had organized the Guest Lecture on the subject of Professional Ethics on the topic "The Ethics in Professional Ethics of an Advocate" on 31ST October 2020, for the Students of LLB V Semester (3 years course) and B.A. LLB IX Semester (5 years course). Total 77 students attended the Guest Lecture through Google Meet.

The session was conducted by Dr. Pratima Lokhande. The Welcome address was given by Dr. Prof. Mrs. H.V. Menon, Head of Department of Law, who explained the importance of Professional Ethics to be observed by an Advocate by emphasizing on the relationship between Judge, Advocate and client. Dr. Pratima Lokhande introduced the Guest Speaker, Adv. Wilson

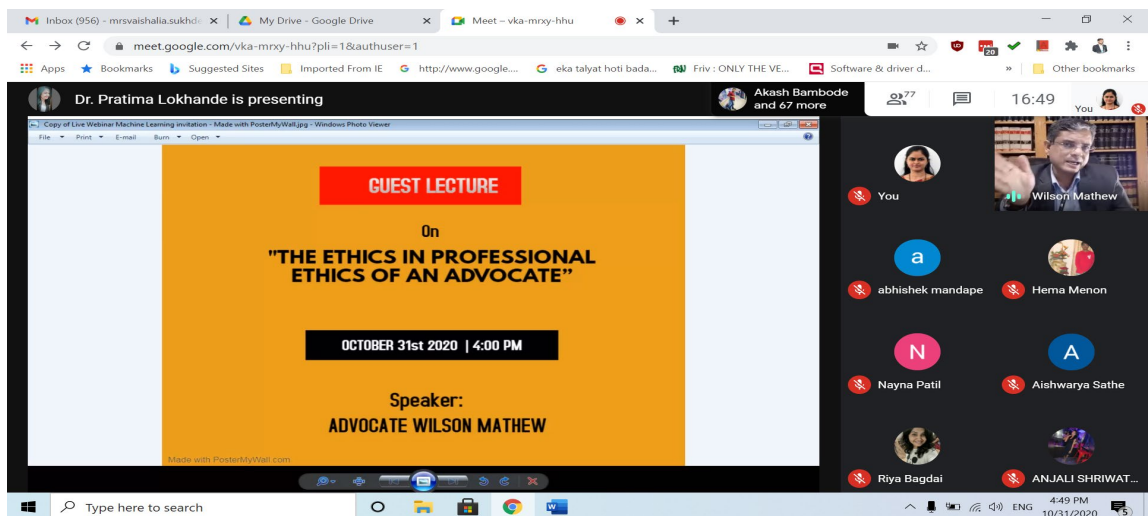
Mathew who is practicing at Bombay High Court, Nagpur Bench, Nagpur, and invited him to address the students on the topic.

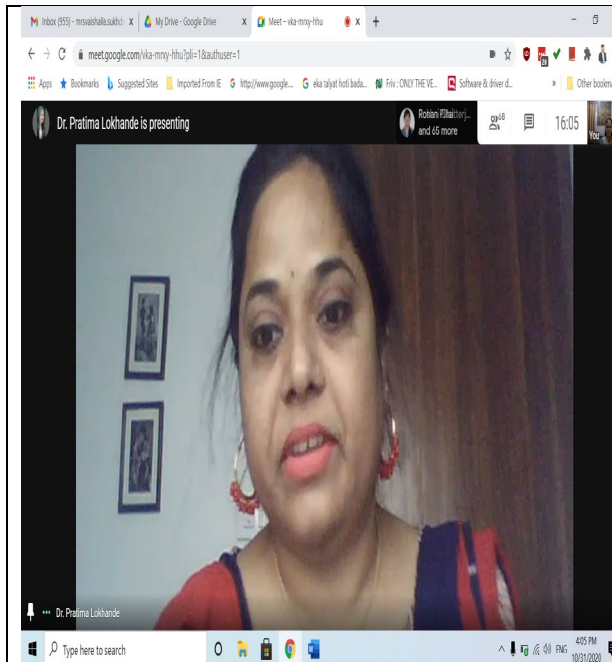
Adv. Wilson Mathew, commenced his lecture by explaining the history of Contempt of Courts Act, and emphasized the need for maintenance of Supremacy and dignity of Higher Judiciary. He further highlighted that Professional Ethics is whole package in itself which includes conduct of an advocate, etiquettes required to be followed along with how the attire and dress code of an advocate also matters. He further stressed on the Duties of an Advocate towards Judges, clients, Opponent Lawyers and also towards the trainees and interns. He also explained that Right to practice of an Advocate is not an absolute right and is subject to certain conditions.

The guest lecture was further followed by Question and answer session which was conducted by Mrs. Vaishali A. Sukhdeve, wherein students put their queries to the Guest Speaker Adv. Wilson Mathew, which were answered in detail to the satisfaction of the students.

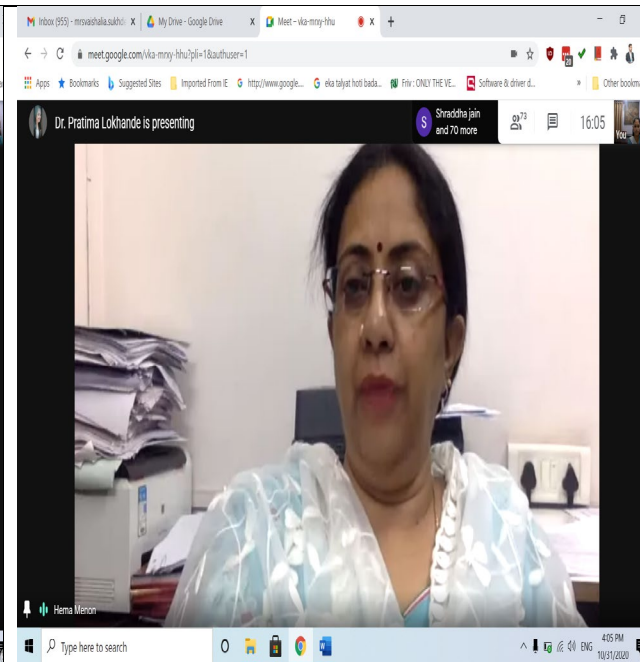

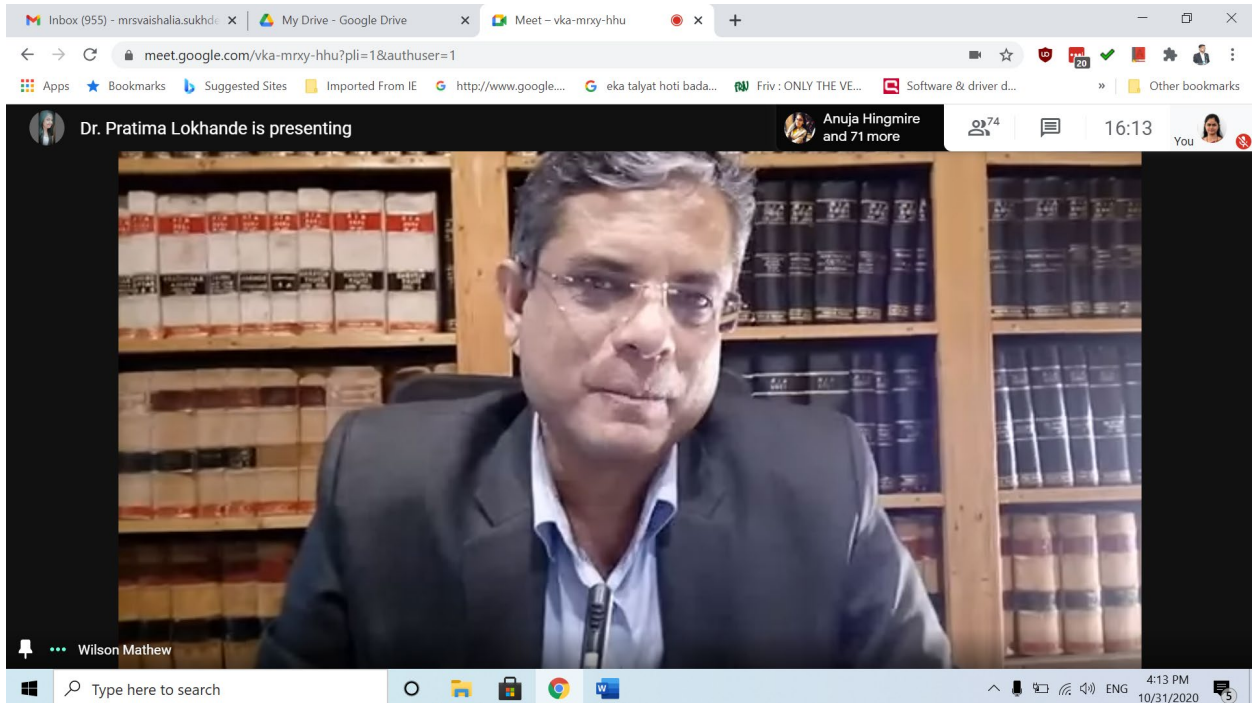




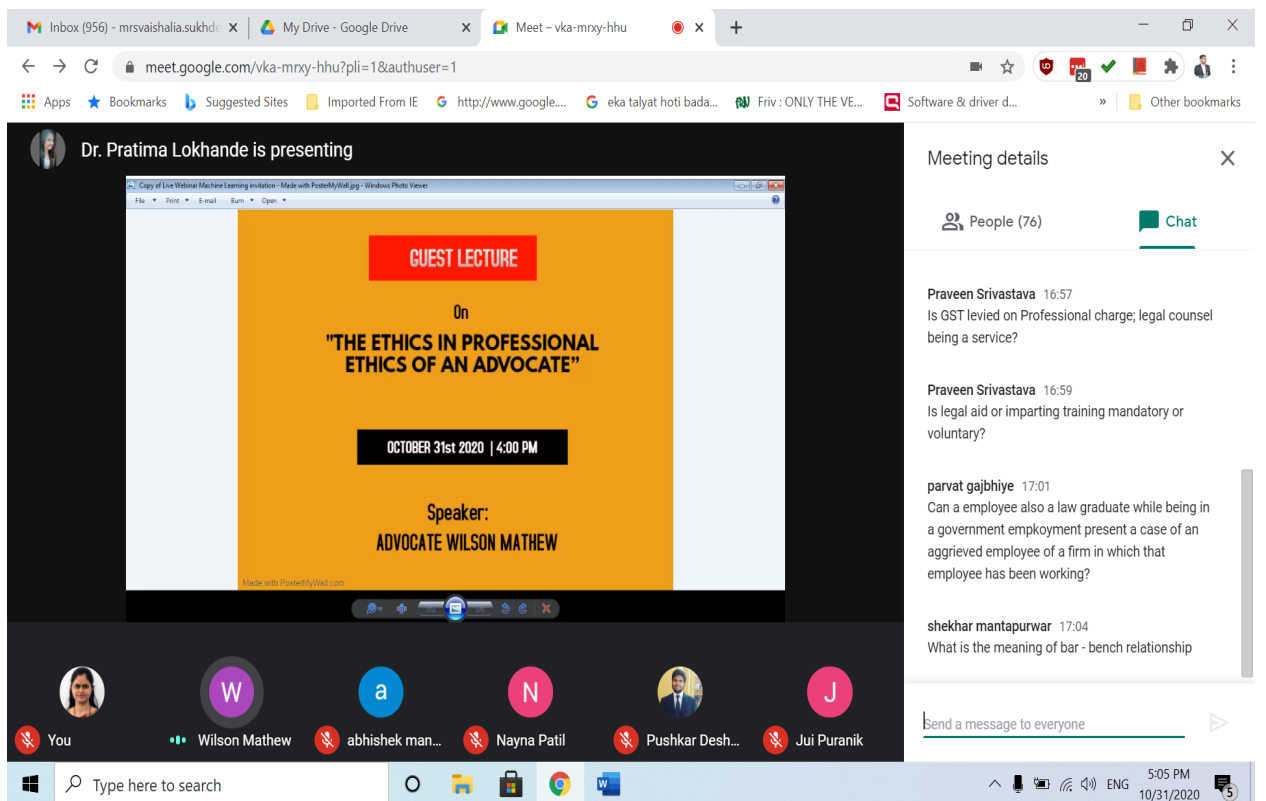
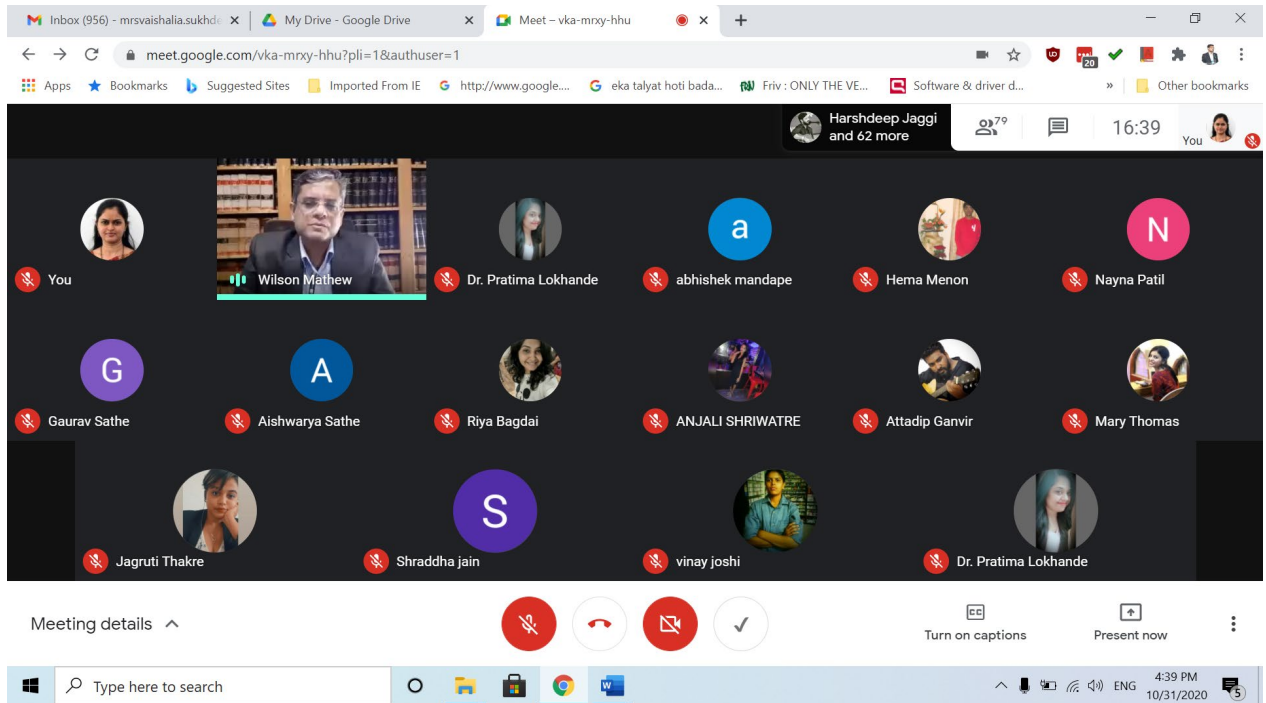
Dr. Pratima Lokhande conducting the Guest Lecture and introducing the Guest.
