“We are sovereign, Law comes from us” were the opening words of Dr. Glen Martin, President, World Constitution and Parliament Association. While delivering the guest lecture on “Climate Change and Legal Perspective” organized by the Department of Law, Dr. Ambedkar College, Deekshabhoomi, Nagpur on 24th December, 2019, he highlighted the importance of preservation of ecological balance. He also emphasized on spiritual realization of humanity as a unique expression of the cosmos. 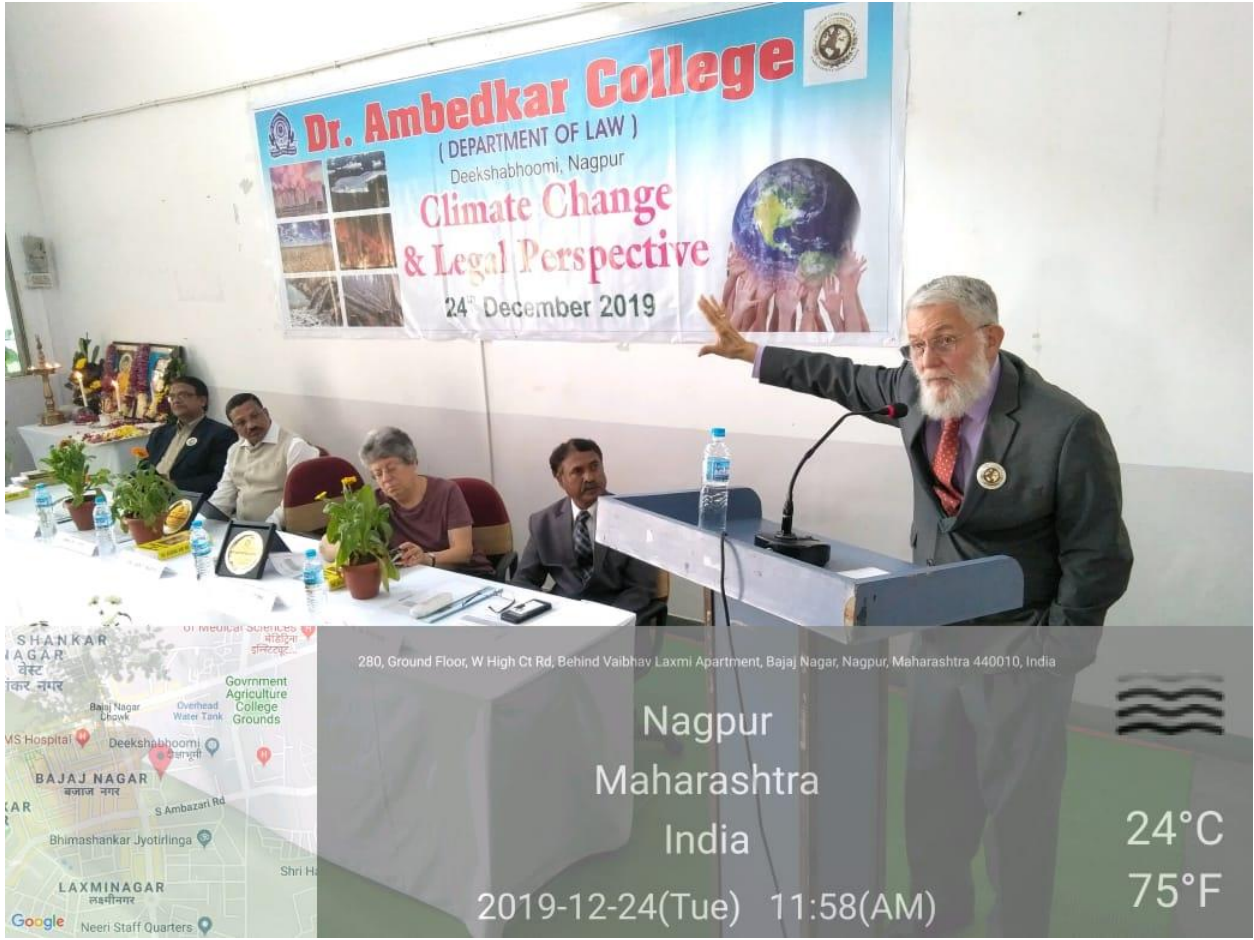
The lecture was followed by the interactive session where the students and the faculty of department of law asked the questions on the global issues pertaining to climate change.

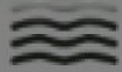
