
**TOPIC:**

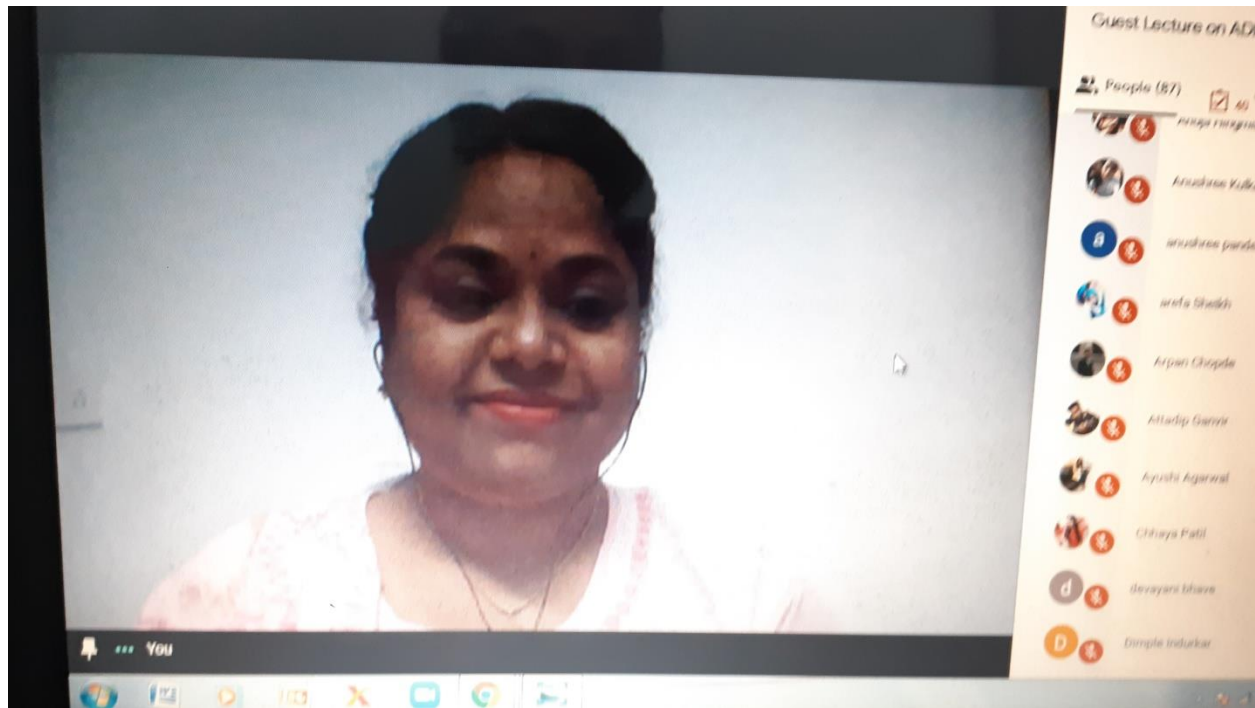
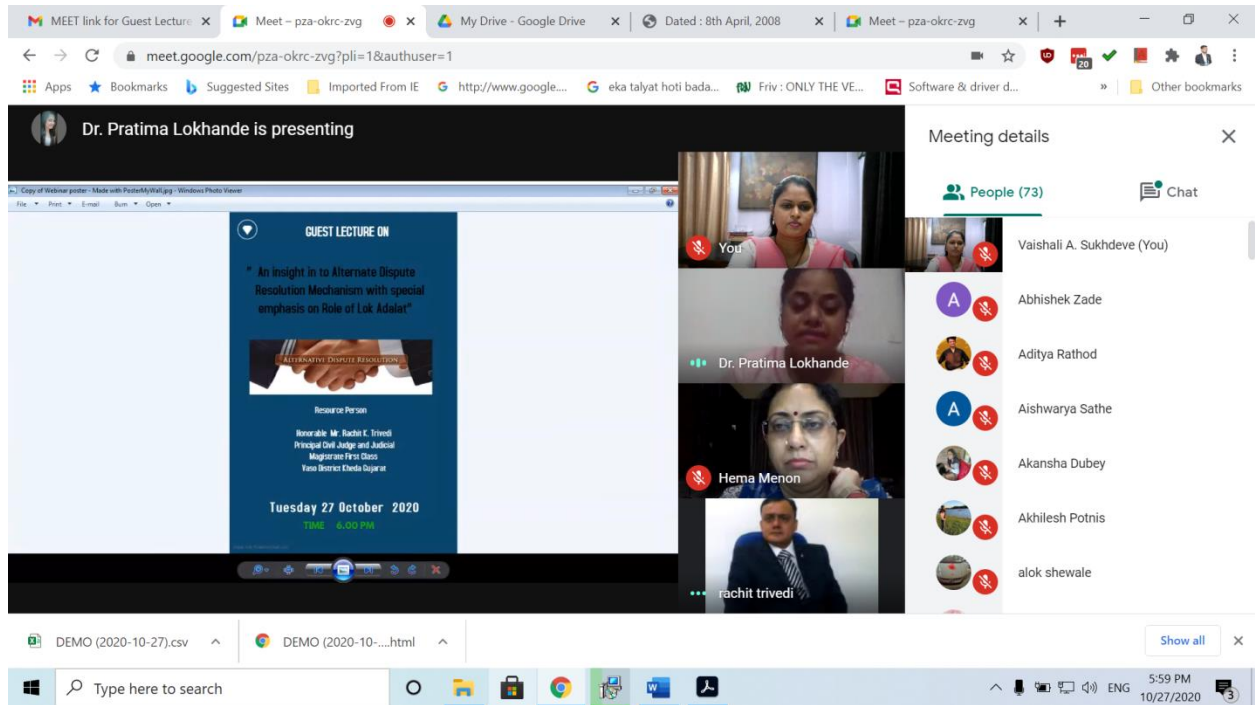


Figure 1 Introduction of the session/ Guest lecture By Dr. Pratima Lokhande, Assistant Professor, Department of Law

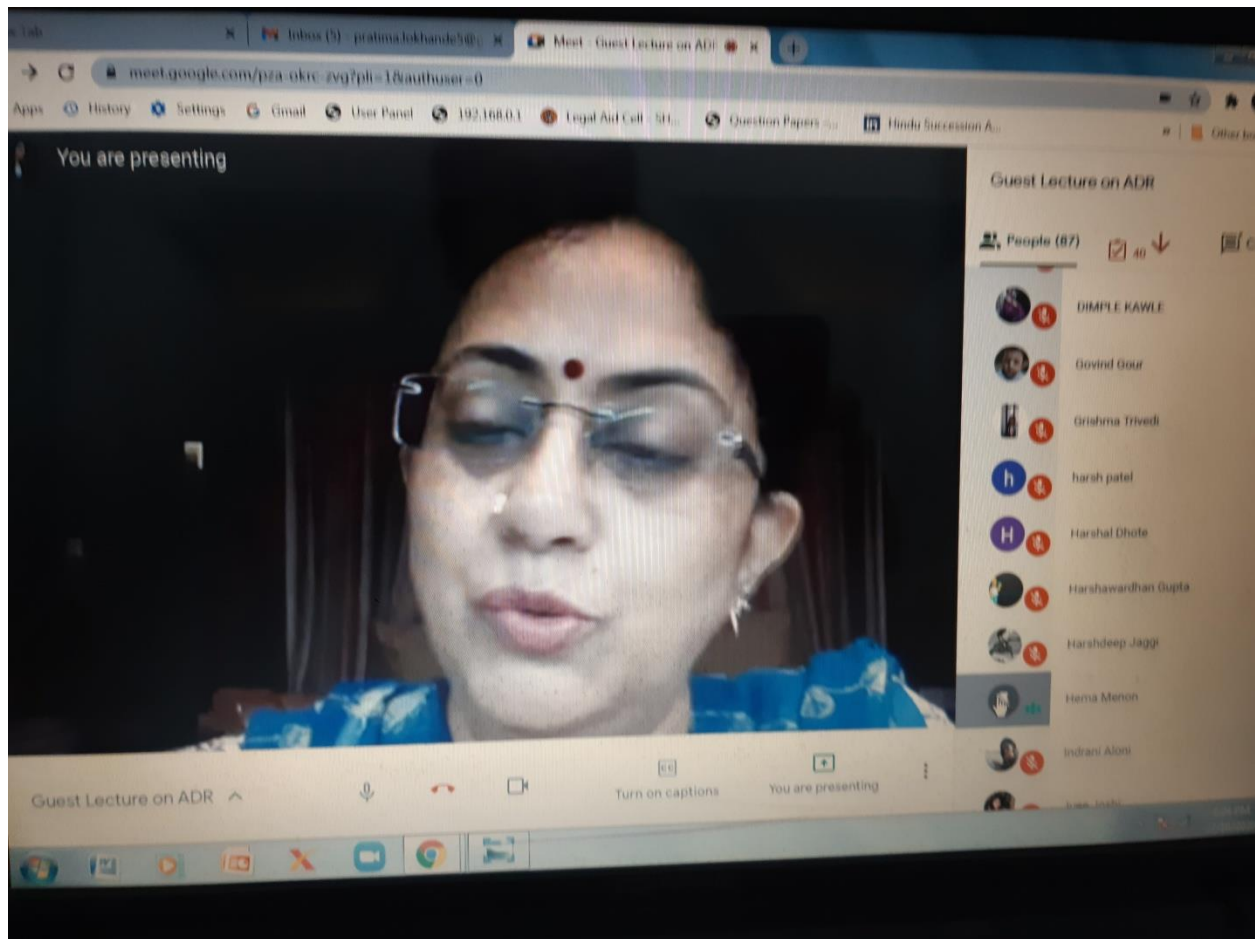


Figure 2 Welcome address by Dr. H.V.Menon, Professor and HOD of Law

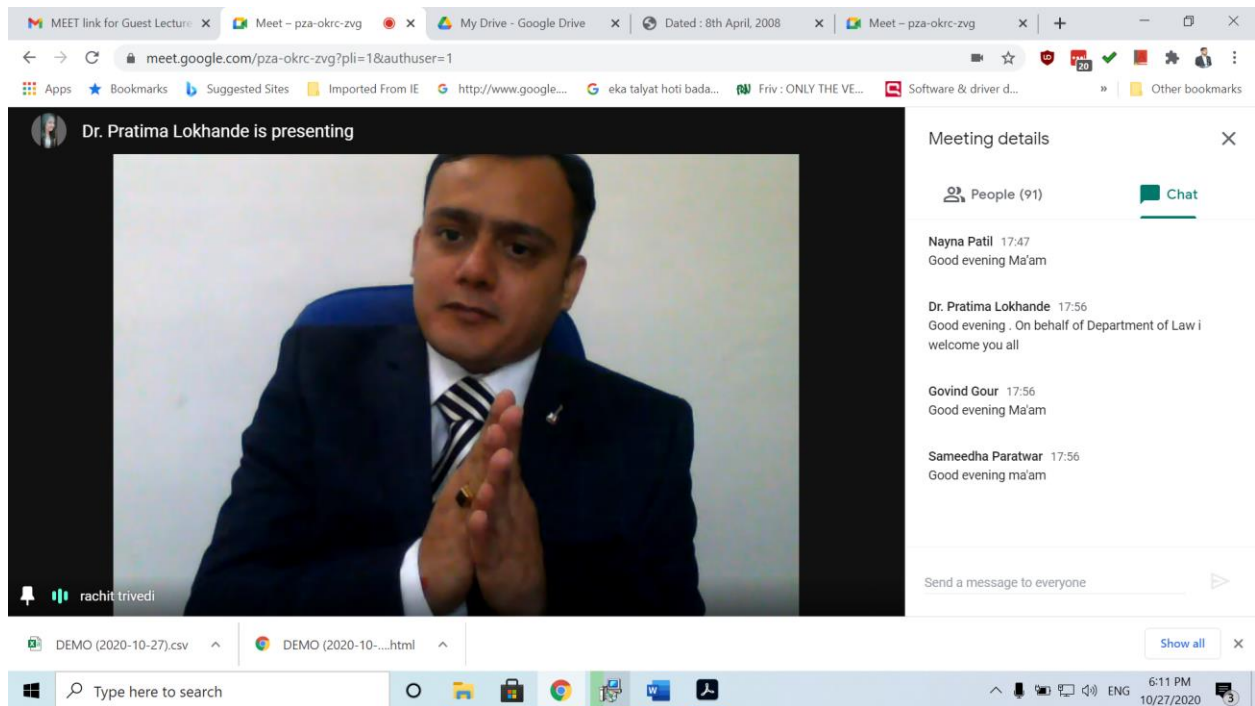
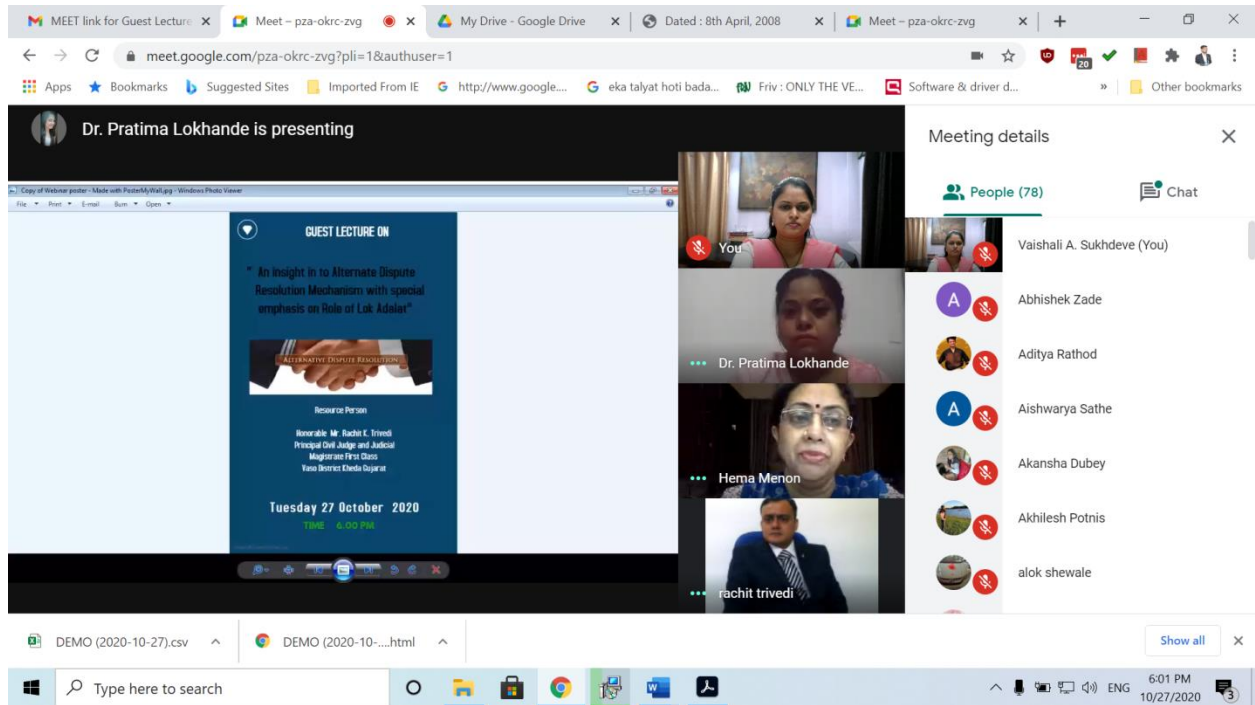


Figure 3 Mr. Rachit Trivedi speaking on the topic, "An insight in to Alternate Dispute Resolution Mechanism with Special Emphasis on Role of Lok Adalat"



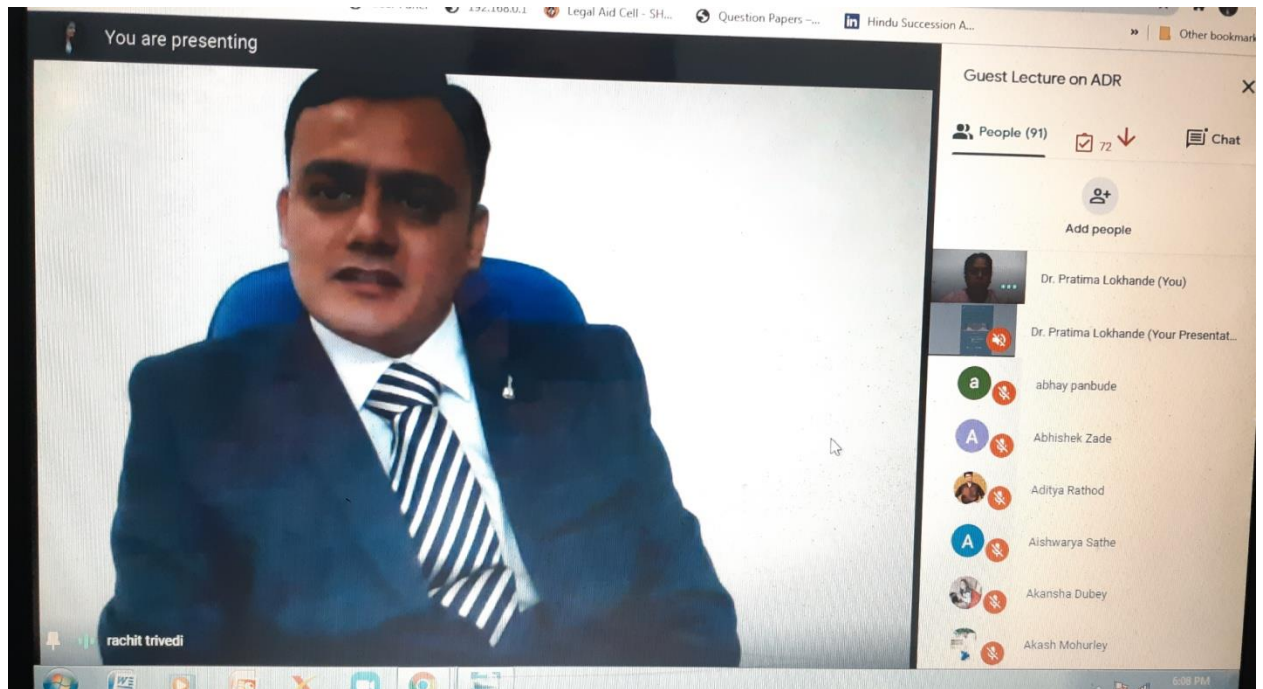


Figure 4 Mr. Rachit Trivedi answering the questions of the students

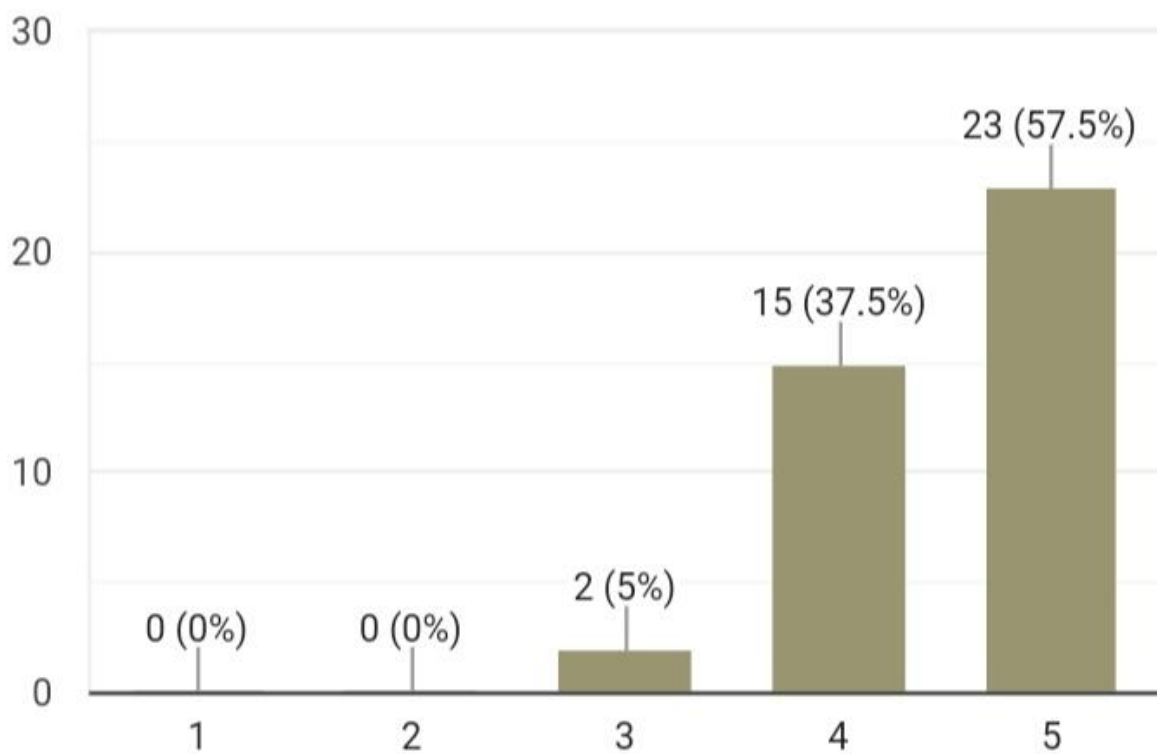

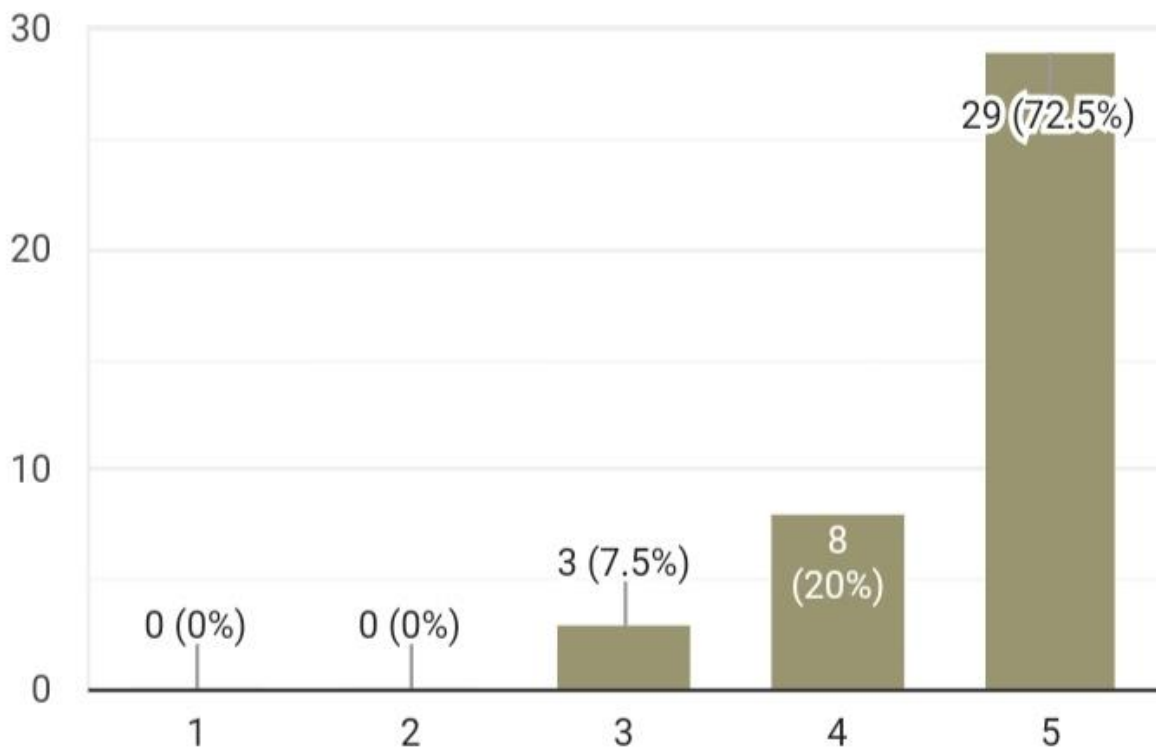
