PTM REPORT

A Parent-Teacher meeting was organized by the Department of Law for the parents of I sem (5yrs) course students on the 14th June 2021. The meeting was held online on the Google Meet platform.

The meeting commenced with a word of welcome by the Co-ordinator of the PTM, Dr Varsha V Deshpande. She welcomed all the parents and briefed them about the purpose behind holding the meeting. Owing to the extreme delay in the CET admission schedule this meeting could not be organized earlier immediately after the admissions of these students. Hence it was planned before the start of the next session. Dr Deshpande thereafter introduced the parents to all the subject teachers who were also present in the meeting. Thereafter the Head of the Department Dr Hema Menon addressed the parents and informed them exhaustively about the College and the Department; its teaching methodologies and discipline rules as well as the broad spectrum of activities hosted by the Department. She also focused in her address on all important issues relating to the students progression. She also emphatically pointed out to the parents the importance of regular attendance in all classes that are held as per the time table, of posting all assignments on time and of appearing in all tests and examinations with complete preparedness. She informed them of the practice of continuous evaluation and assessment followed in the Department and that hence it was important for students to remain present and meticulously follow all schedules and timelines for submissions. Dr Menon informed the parents about the use of Google Classroom by teachers which has been done in the Department from times even prior to the closedown due to the pandemic. The parents were also given detailed information of the wide variety of activities that had been organized for the students and the different cells that

After this, the forum was let open for parents to interact, to voice their concerns and give suggestions. The parents gave in many valid suggestions, especially from the point of view of making the online classes more engaging for the students. Thereafter the meeting ended with a vote of thanks by the PTM co-ordinator, Dr V V Deshpande.

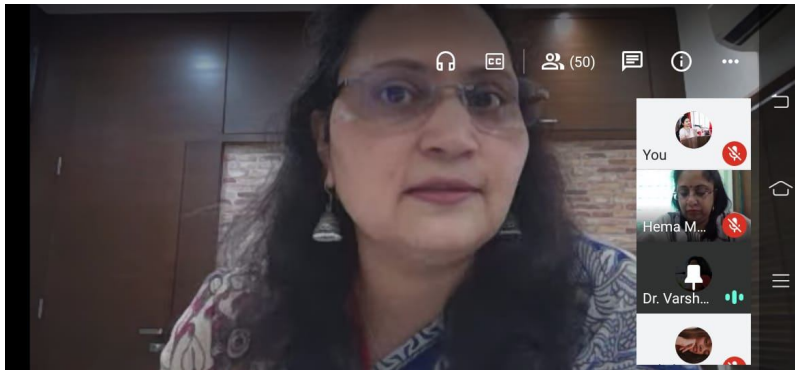


Figure 2: CO-ORDINATOR, PTM ADDRESSING THE PARENTS

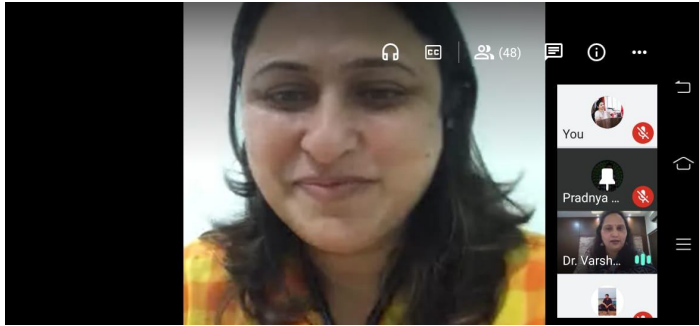


Figure 3: A Parent interacting at the PTM
