Guest lecture was conducted on 01/05/2021 on Aviation and Marine Insurance in International Contracts. Guest Lecturer Adv. Rahul Dhande was welcomed by Dr. Hema Menon (Professor & HOD-Department of Law DACN). Adv. Rahul Dhande is practicing in the expertise of IPR, Litigation and other Commercial Laws. He provided his insights on both Aviation Insurance and Maritime Insurance. We saw what do we mean by the term "insurance" and different types of insurance such as life insurance, health insurance, etc. Insurance is a means of protection from financial loss. Followed by the introduction of aviation laws under the Montreal and WARSAW Convention along with Domestic and International laws governing the marine sector. The first part of the lecture addressed the current Aviation Industry's status in India and India is a blooming Nation in the aviation sector, what is the need for Aviation Insurance in today's time. The second part of the lecture highlighted Marine Insurance and how in the era of globalization we have seen transport and trading of goods have increased through the medium of sea. In conclusion, we saw that there is an increase in the trade activities through Air and Sea and it is required by the parties in a contract to have insurance to avoid losses due to unexpected situations and contingencies.
