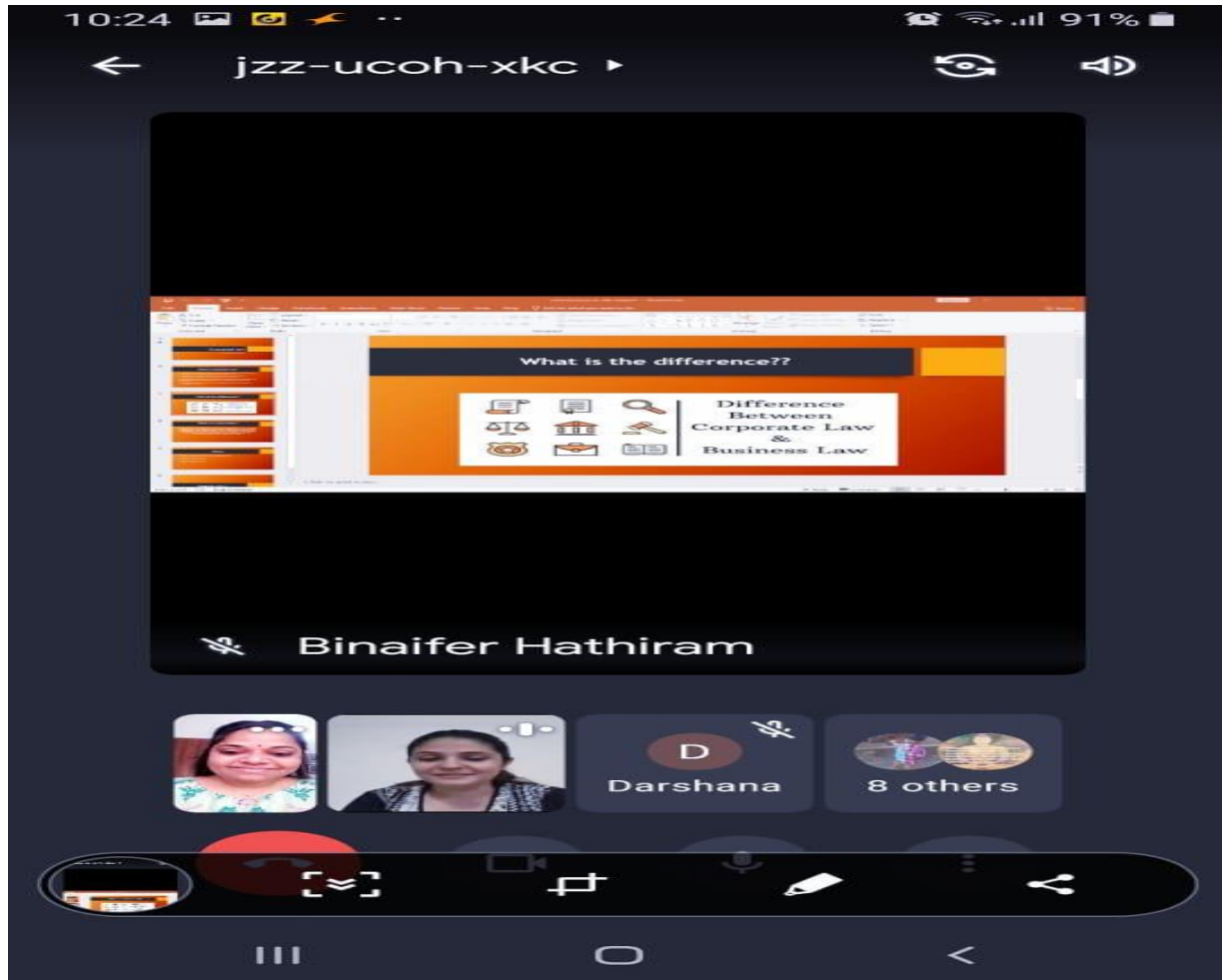

## **REPORT:**

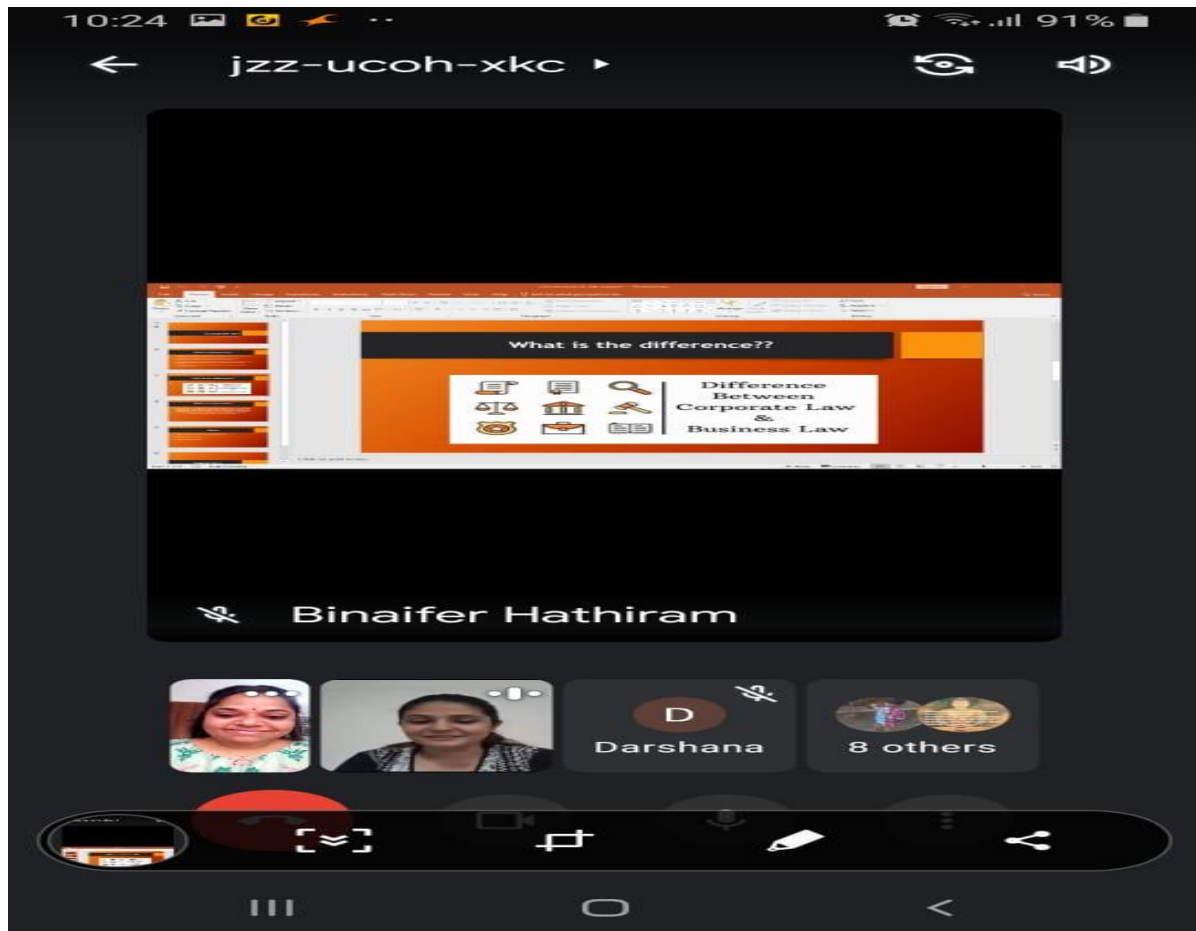
