On 24th April, 2021, an Online guest lecture was conducted by Dr. Ambedkar College, Department of Law, Deekshabhoomi, Nagpur for the newly admitted students of LLB I Semester (3 years and 5 years course). Total 122 students attended the program. Prof. Dr. H.V.Menon, Head of the Department of Law, Faculty Members, and all Visiting Faculties teaching in LLB I Semester (3 years and 5 years course) joined the online Program through Zoom Meeting at 3.00 P.M.

About the speaker

Advocate Chetan Dhore is a law graduate from Dr Ambedkar College Deekshabhoomi Nagpur and with gold medal in constitutional law in his masters (LLM) from Rashtra Sant Tukadoji Maharaj Nagpur University. Practicing as an Advocate in High Court of Bombay since 2010 and in different courts all over the India including different tribunals and the Supreme Court of India. Specialisation are drafting and pleading civil litigations, Public Interest Litigation, Writ petition under article 32 of the constitution. He is imparting training to group A gazetted officers recruited under the Indian Ordnance Factories Act. Special command on arbitration and conciliation act.

Objectives/ preamble

The objective of the online lecture was to focus on different aspects of "synopsis writing" where in the participants learn the art of synopsis writing that is how to write case brief/summary. To guide students towards increasing critical reading and analytical skill as well as greater understanding of the case.

The course content delivered in the webinar is as follows "SYNOPSIS WRITING"

The speaker of the session Adv. Chetan Dhore presented the keynote address on introduction on topic synopsis writing and the basic concept of writing a case brief/summary and its importance in legal studies.

The speaker explained the meaning of briefing as a way of to isolate the significant elements of judicial opinion and preparing a short-written summary of that information. He added how to prepare these written summaries which serves different purposes at different times. Told the students that briefing requires to read cases actively and critically. Said that one has to read the court opinion very carefully and decide which information is important to the result and which is not. He added that case brief should contain enough information what but not too much.

By active reading student identify the rules of laws found in the court cases and analyse how Court apply this rule of law to the facts of a case in an objective and rational manner and also focused on using strategies to consolidate critical information and details into fluid summary. He explained the various components of a case brief like relevant facts, issues. Contentions, law points, rule of law in detail during the lecture.

At the end of the session, he inspired the students by lively interacting on technicalities of case briefing and summary writing.
