

REPORT ON WEBINAR

"ENGAGING MEN IN THE PREVENTION OF SEXUAL HARASSMENT"

The Internal Complaints Committee, Dr. Ambedkar College, Deekshabhoomi Nagpur, has organised a webinar on "Engaging Men in the prevention of Sexual Harassment on 28th Oct, 2021 for the students of Arts, Commerce, Science, and Law Faculty. Total 165 attendees were present in the programme.

The resource person of the workshop was Dr. Aneesh Pillai, Assistant Professor, School of Cusat Kerela .

The program commenced with the welcome address by Prof. Dr. Mrs.B.A.Mehre, Principal Dr. Ambedkar College Deeksha Bhoomi Nagpur to the well acclaimed Guest speaker, Dr. Aneesh Pillai, the faculty members of the departments, and Invitees and students.

Dr. Aneesh, started lecture with questions like what is a right? what is the scope of right? what is the status of this right? which really made them attentive from the very beginning. Highlighting importance of this piece of legislation which is meant to protect the vulnerable section i.e women. He highlighted sensational cases.

After highlighting the important previous issues, explained all the relevant provisions and particularly emphasize upon the preventive measures under chapter IV of the legislation.

Dr. very aptly and sensitively covered all the aspect of sexual harassment and Right against sexual harassment at workplace. Explained Vishakha's guidelines and significance of Vishaka case and eventually told the students that there is no precise definition of sexual harassment and how it has been originated from article 21. Recommendation referred by the Indian committee and how Indian Judiciary evolved the concept of sexual harassment from time to time under article 21 of the Indian Constitution and also explained none of the articles directly referred for dealing cases related to sexual harassment but it has been dealt within the scope of article 14, 15, 16 of the Indian Constitution.

He also explained how international conventions related to this can be inculcated and how the legislative gap in Indian context can be filled by referred for this purpose. How this is trying to protect and deal with sexual harassment.

And then explain what is sexual harassment and what are the effects of this on the victim. How complaint can be registered under the act provision under IPC against sexual harassment at workplace. Duty of the employer to frame rules regarding the same.


Explain the mechanism of the complaint committee and different committees under the act and also explain the role of enquiry committee which can direct but it cannot take action against the wrongdoer. Also Told the relief and interim relief available to the victim, Quantum of punishment and duties of the employer.

He also covered provision under the penal Indian Penal Code against sexual harassment at work place like outraging the modesty, Assault or criminal force to woman with intent outrage her modesty assault or use of criminal force, Voyeurism, words and songs intended to insult the modesty of woman section 509 of IPC were also covered.

Lastly, he concluded that by showing his concern that not much has been done for and how engaging man in prevention of sexual harassment can be dealt with.

The Programme was compared by Mrs. Vaishali Sukhdeve under the guidance & supervision of Dr. Mrs. Sandhya Kalamdhad, Associate Professor Co-ordinator Internal complaint committee Dr. Ambedkar college Deeksha Bhoomi Nagpur.


The event concluded with vote of thanks proposed by Mrs. Vaishali Sukhdeve to the Guest speaker and also to everyone who was present to witness the event.









