She pinned him with the badge of the President and he subsequently installed his entire team of Core-Committee members and Executive Committee members. Soon after all of them were installed, the Executive and the Core Committee members were administered an Oath before entering office, as per the

Constitution of SMCA. The oath was administered by the Supervisor of SMCA, Dr Mrs Hema Menon. After this Oath taking ceremony, the President Mr Chaitanya Mohgaonkar delivered his impressive acceptance speech, in which he thanked the teachers of the department in reposing trust in him by choosing him for the coveted post of the President of SMCA. She also threw some light on the nuances of advocacy and how students must take maximum benefit of activities like moot courts which are wonderful forums available to students today. The main focus of her lecture was on encouraging students to take to the challenging career of legal practice rather than settling for a fixed pay package in corporate. She emphatically pointed out that hard work and patience definitely pays in the legal profession in which sky is the limit. She also passionately urged to the girls students to stay on in the profession rather than dropping out after a year or so which is generally the trend in the court. She also congratulated the teachers of the department for the innovative programmes they organize under the auspices of the SMCA each year.
