On 12<sup>th</sup> February, 2021, Department of Law through the Student Moot Court Association (SMCA) of Dr. Ambedkar College, Deekshabhoomi, Nagpur organized a national level webinar on the topic of '*Gender and Law*'. Around 311 participants attended the webinar. Principal, Mrs. Bhumi Mehre, Prof. Dr. H.V.Menon, Head of the Department of Law, Dr. Varsha Deshpande, Dr. Sandhya Kalamdhad, Dr. Pratima Lokhande, other Faculty Members in LLB ( 3 years and 5 years course) and LLM joined the online Program through Zoom Meeting.

The webinar was carried on in two sessions. The first was graced by the esteemed speaker Adv. 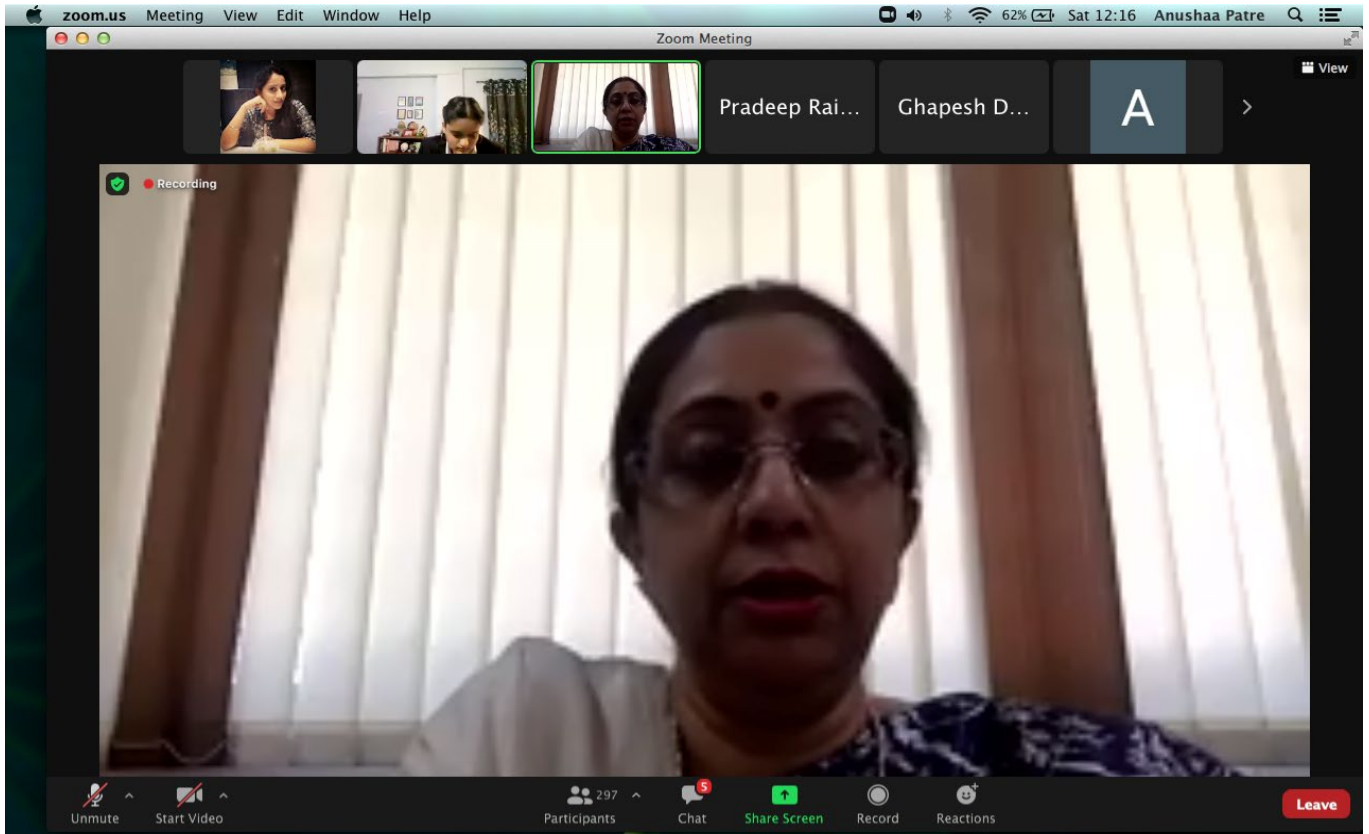

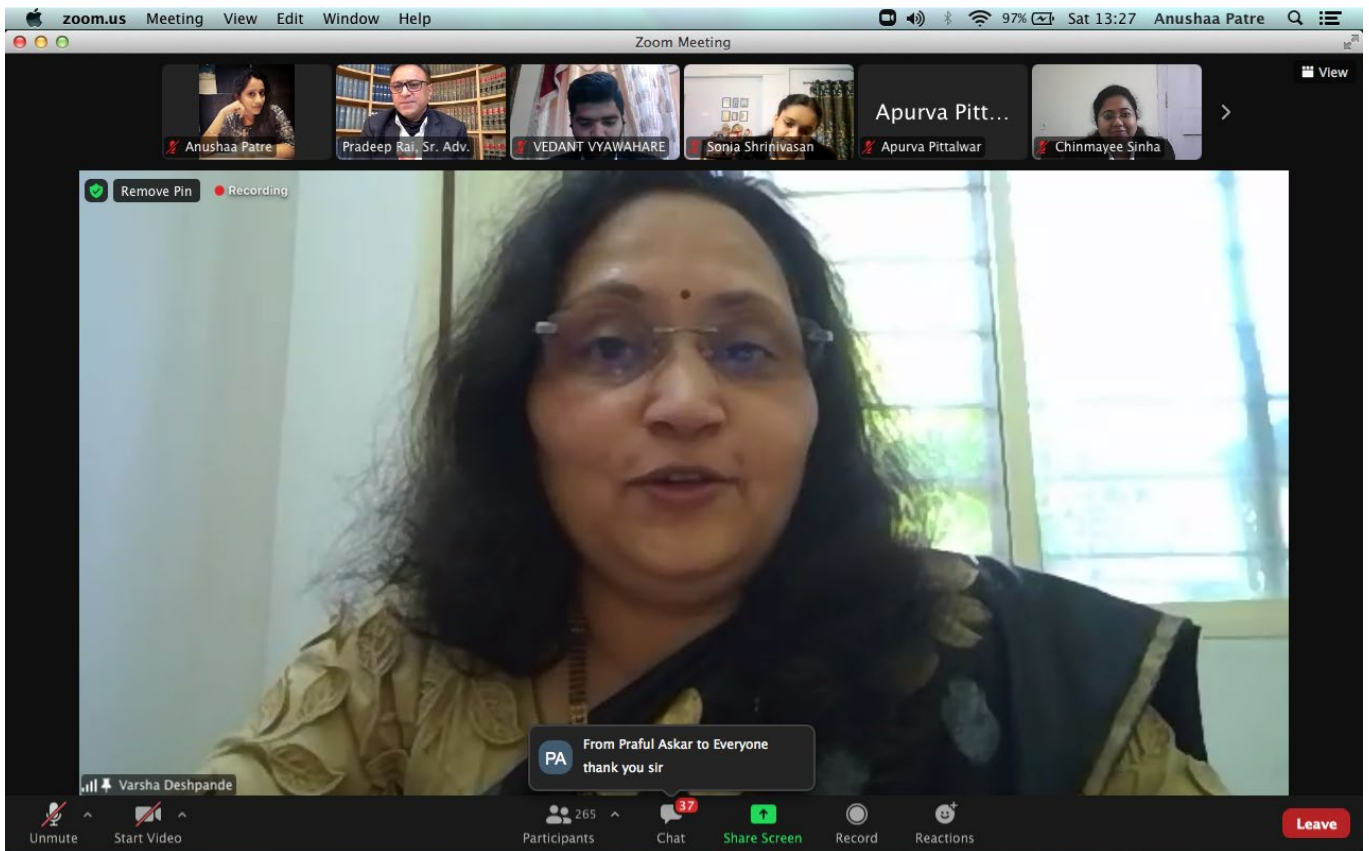

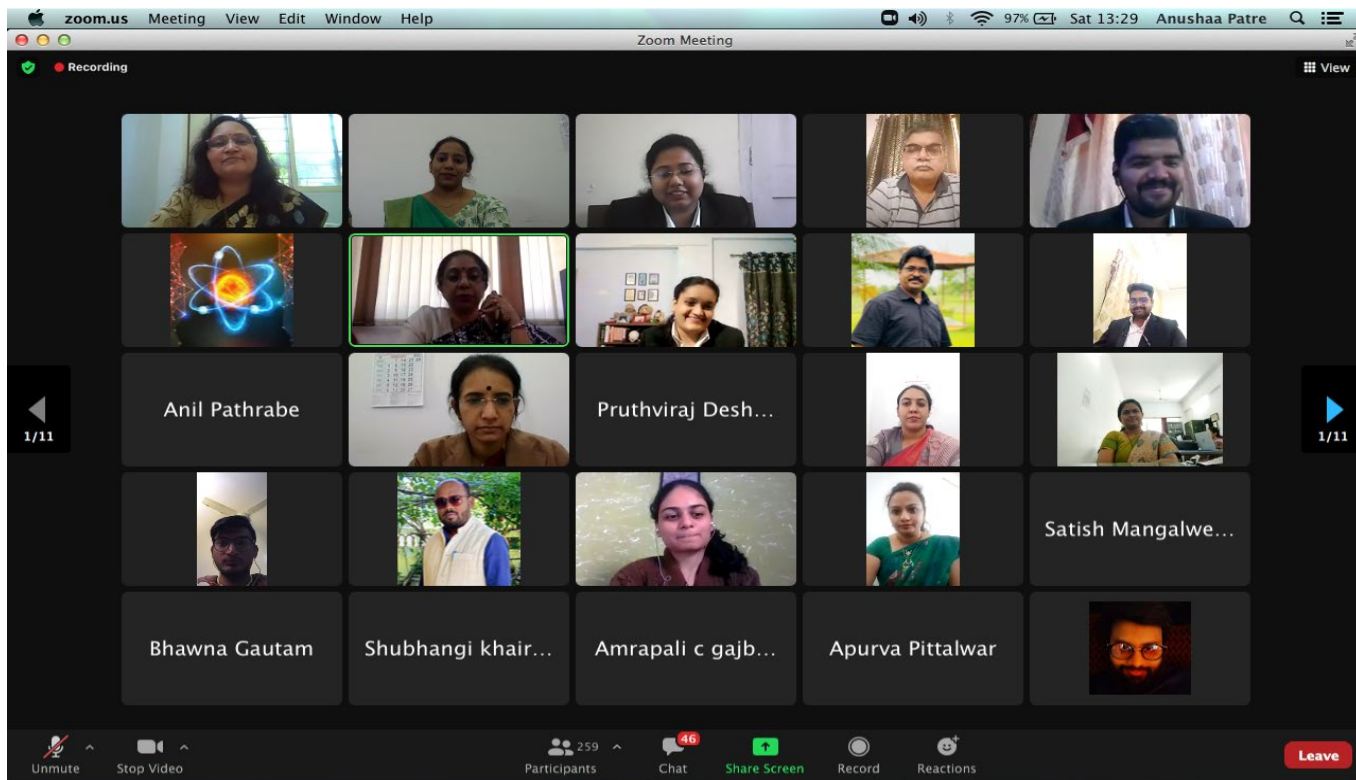


Dr. Pradeep Rai while addressing the participants
