The preliminary rounds saw 8 teams competing for the qualification to the finals. Two teams emerged victorious with the highest overall score and we're selected for the Final Round of In-house Moot Court Competition which was organised on 15/10/22.

The students willing to participate as audience were also allowed to do so. The Courtroom was packed with enthusiastic audience, all eager to learn.

The moot problem was same as the preliminary one. The problem chosen was based on the sensational and much-talked about topic of women's right to entry in the Sabrimala temple. However, certain changes had been made and certain deviations were kept, so as to make it more challenging.

The memorials were collected on 13/10/22 following which the written submissions were concluded. The teams got to know the side they would represent and the team they would argue against. They were also given 10 minutes extra to put their arguments more eloquently and effectively in front of the Bench.

Speaking of the Bench, the college was honoured to have Adv. Renuka Sirpurkar and Adv. Shradhanand Bhutada as the Hon'ble Judges for the competition. Undoubtedly, the students were very delighted as well as nervous, in equal parts, to be arguing in front of such knowledgeable personalities. At the end, the Judges departed the college with great satisfaction and words of affirmations for the participants. The participants had already won there, for they had left the judges impressed. The results of the same were declared on 18th October. Team D, consisting of Ms. Nishta

Singh, Ms. Subhusha Agarwal and Ratiksha were declared as winner with highest marks, Best memorial was again bagged by Team D with Best Mooter from Team D itself.
