Moot Courts are the highlights of any law student's life. After all, it is there that the student has the first taste of lawyering. It wouldn't be wrong to say that mooting is the closest a law student can get to being an actual lawyer. Thus, it is extremely important that they receive proper and adequate guidance in the same. With this thought in mind, The Students' Moot Court Association of the Department of Law, Dr. Ambedkar College, Nagpur organized a Workshop on Moot Court on the 26th of December 2022 for the students of LLB I Sem (3- and 5-Year's course). Under the guidance of Adv Rahul Dhande and Adv Wilson Mathew both practising advocates from the Nagpur Bench of the Bombay High Court, the students were taught the basics of mooting- which start right from reading a proposition to drafting a memorial.

In order to make the whole learning process more effective, the students were circulated the moot proposition beforehand and were expected to be acquainted with it.

Adv. Rahul Dhande Sir went into great detail on the purpose of competing in moot court competitions as well as its significance. He clarified the proper format for writing a memorial and highlighted the value of conducting research before drafting it. While Adv. Wilson Mathew Sir enlightened the students upon the dos and don'ts which are to be taken care of while arguing a case in a Mock Court. He also shared his personal experience with Mooting in National and International Competitions and encouraged students to use their free time wisely beginning in the first semester.

The resource persons were kind enough to explain all the nitty-gritty of it. They also explained to the students how to look past the irrelevant facts, onto the relevant ones, to see the issues at hand. The resource persons also explained the method of researching for a moot. How one may browse through countless case laws and arrive at the most fitting one, is often a matter of stress for beginners. They were patient in explaining that as well, while also emphasising the significance of good research work. After this, the resource persons shifted the focus to the drafting of memorials. Certain cardinal rules of drafting were elucidated which gave the participants a very clear idea about how they may proceed with the drafting. The speakers also demonstrated how good drafting makes a difference in presenting the case before the court. Some apt examples were cited by the speakers to illustrate this point. The speakers left no stone unturned in enlightening the students and this could be best observed when they taught basic court mannerisms to the eager audience.

The students had a slew of questions for each speaker, which they answered to their satisfaction. After an interactive session, Ms. Anmol Sahu proposed a vote of thanks to Adv. Rahul Sir and Ms. Aditi Singh proposed a vote of thanks to Adv. Wilson Sir, and the workshop was concluded by presenting both of them a memento on behalf of the entire Students' Moot Court Association. The participants as well as the organizers were indebted for the patient and kind demeanour and teaching style of the speakers. The audience left with a feeling of confidence and eagerness to learn more while the speakers parted with having taught probably the most enthusiastic participants ever!
