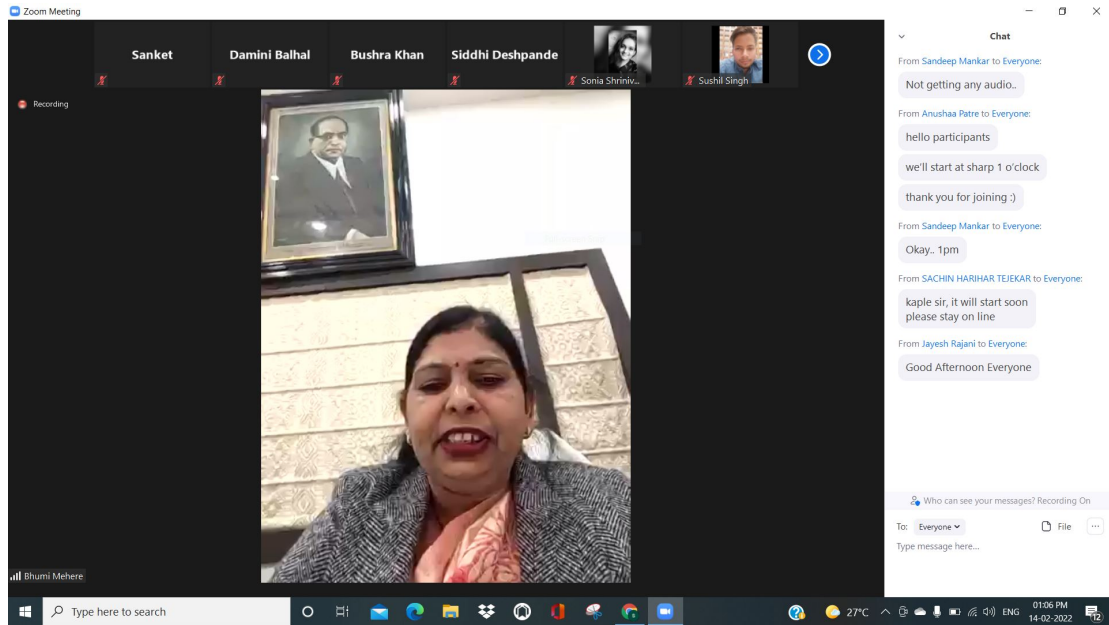

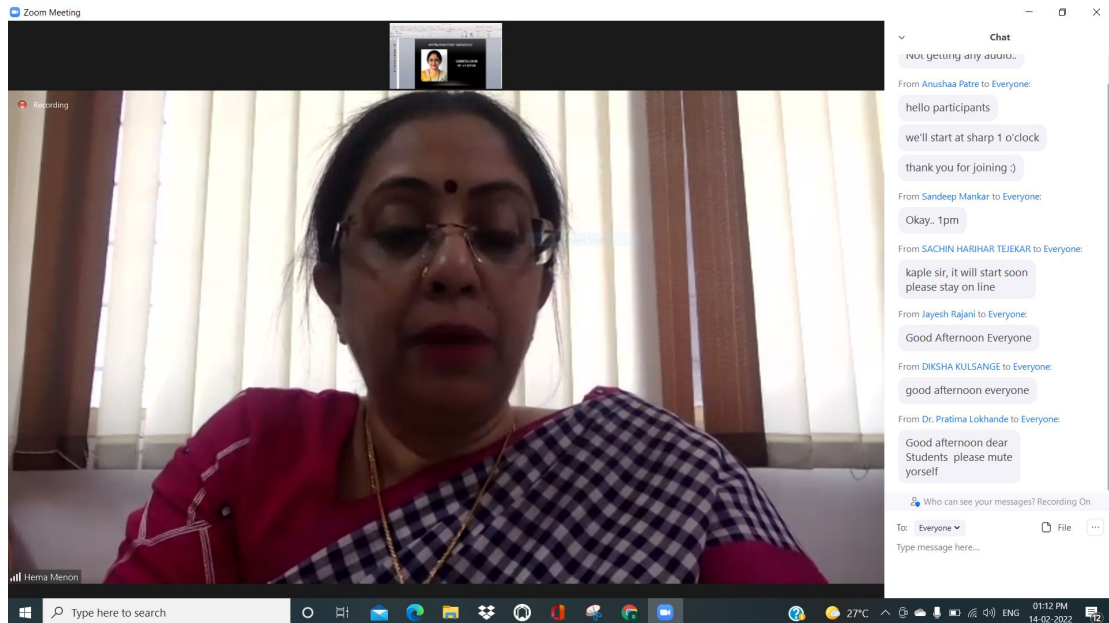

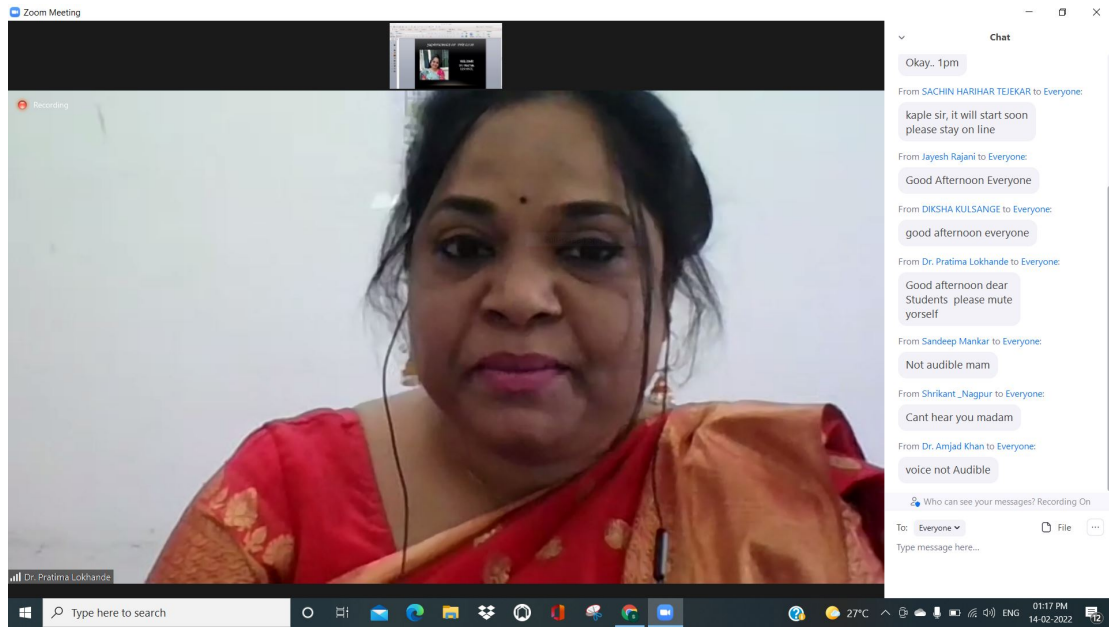
The Ceremony concluded with Ms. Anusha Patre proposing a vote of thanks and the opening of registration was announced by Dr. Pratima Lokhande.



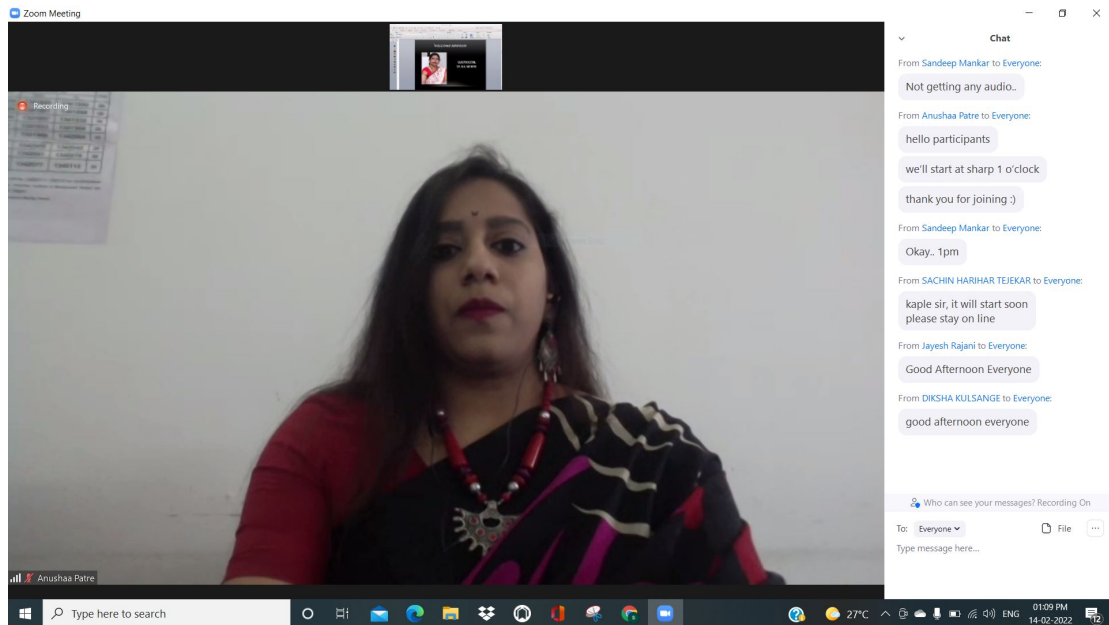
PRINCIPAL, DR. B.A.MEHERE DELIVERING THE WELCOME ADDRESS



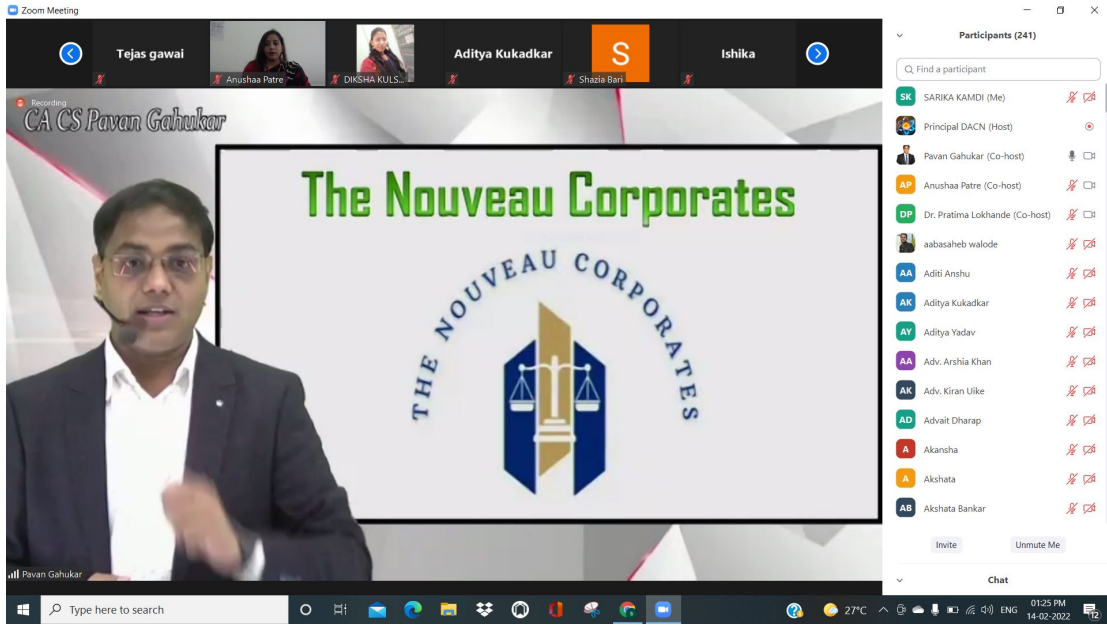
