



He covered various related topics such as Anti Trust Laws in USA reflecting upon the Sherman Act of 1890 and Clayton Act of 1914 which was considered as the turning point for the development of Competition Law, Federal Trade Commission Act, EU Competition Law and other related aspects. He threw light upon the Anti- Competitive agreements and its types and the exhaustive regulation of Merger regulations in India.


He shared examples of the Oil Industries and Telecommunication sector to explain in intricate detail about the working of competition in the Indian Market.
