



**REPORT ON ONLINE QUIZ ON “EMERGING TRENDS IN HUMAN
RIGHTS”
THROUGH
“CRIMINAL LAW CLUB”**

Department of Law, Dr. Ambedkar College, Deekshabhoomi, Nagpur through “Criminal Law Club” had organized Online Quiz on “Emerging Trends on Human Rights”, on 10th December 2020 to mark the celebration of International Human Rights Day 2020. This online quiz was designed to create awareness among the budding lawyers about new emerging trends in Human rights. It was organized for the Students of LLB (3 years course), B.A. LLB (5 years course) and LLM. Total 121 students registered for the quiz. Out of which 59 students participated through Google Meet and attempted the quiz through Google Form shared in Google Classroom. The quiz consisted of total 30 questions. Each question carrying 2 marks. The Google meet was scheduled by Dr. Mrs. Sandhya P. Kalamdhad and all the important instructions regarding quiz were given accordingly. The time window of one hour was given in which students had to respond to quiz from 11 AM to 12 PM. The acceptance of responses of Google form was closed sharp at 12.00 PM.
