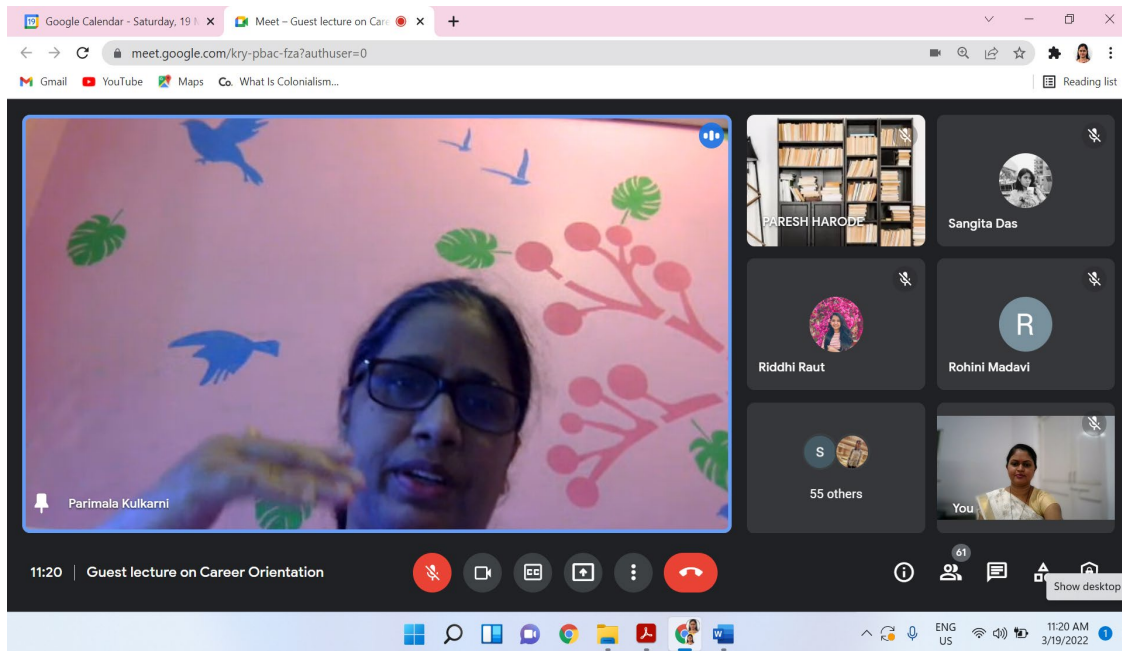

She also emphasised that application of knowledge and wisdom plays a significant role wherein the students should understand first and then apply the law. Team work is requisite in corporate career.

Adv. Kulkarni further gave a comprehensive explanation on various fields involved in corporate career. She highlighted each field in a very lucid manner. It involved different areas like real estate, power sector, textile, intellectual property, cyber laws, labour and industrial laws, company and commercial laws. Taking into considerations all these areas, Adv. Kulkarni further guided the students to learn add-on courses in law involving Taxation, family laws, consumer laws,

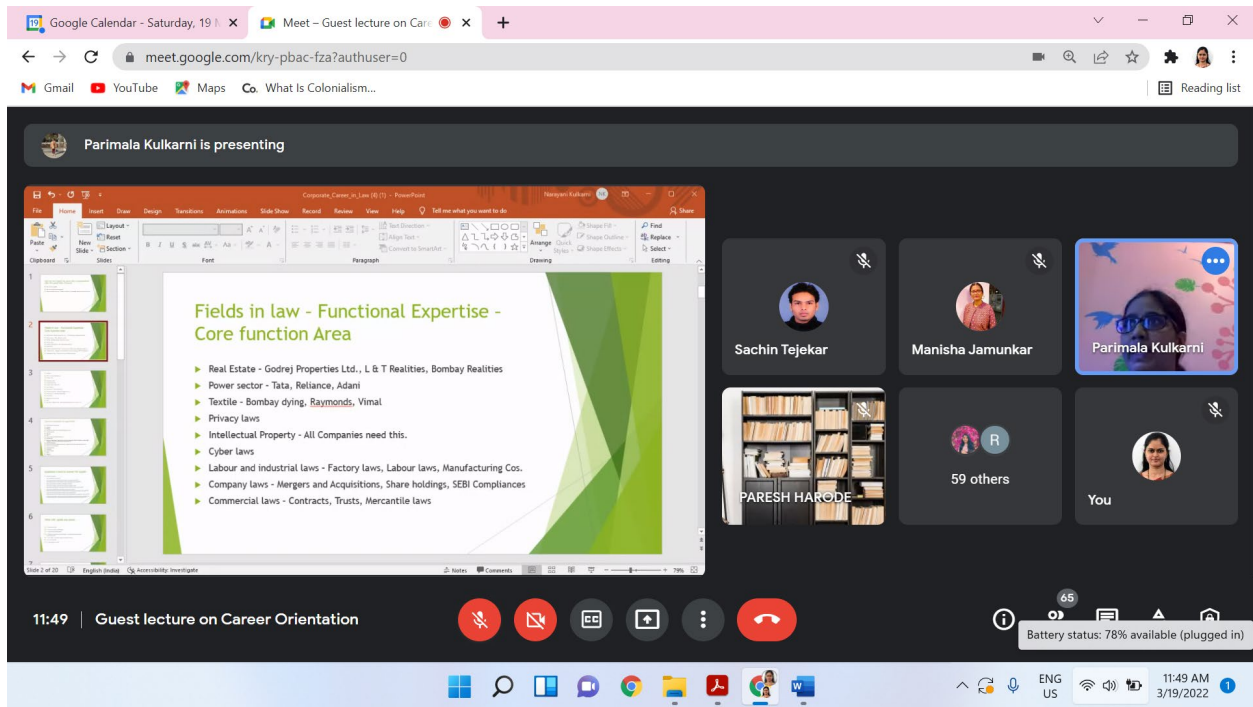
competition laws, service laws, banking, arbitration, mediation, conciliation and should also possess the knowledge of Document registration.

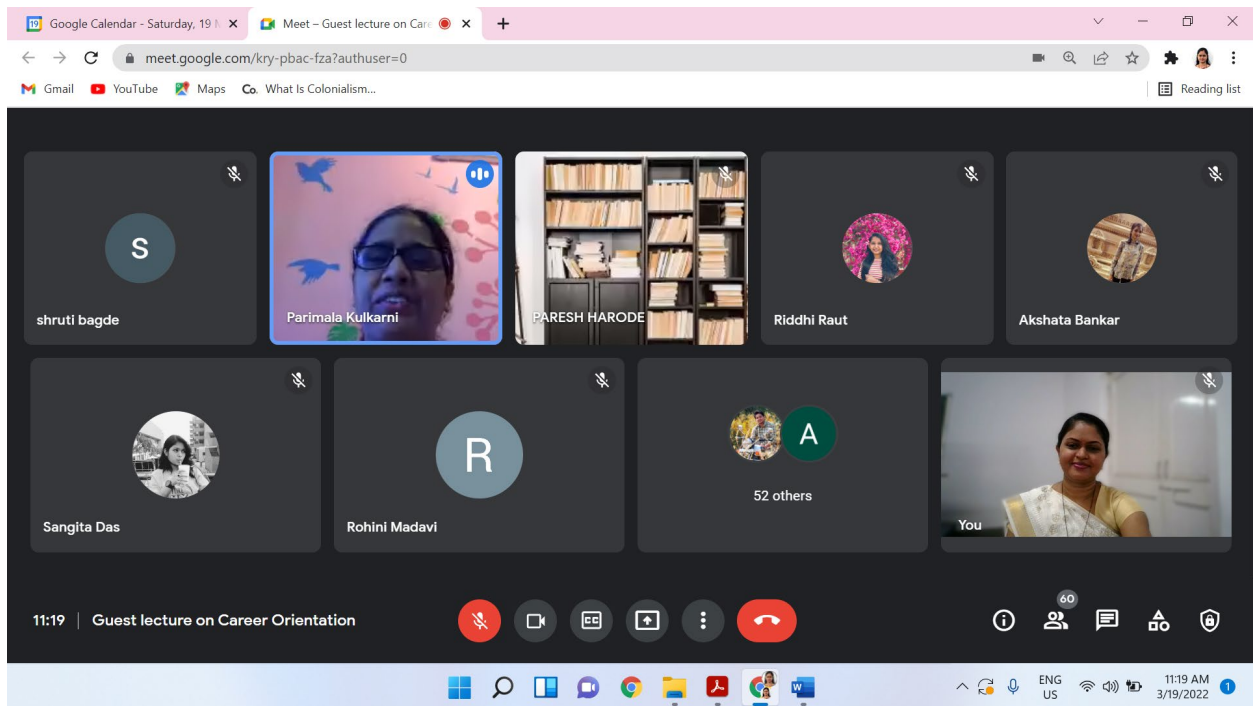
