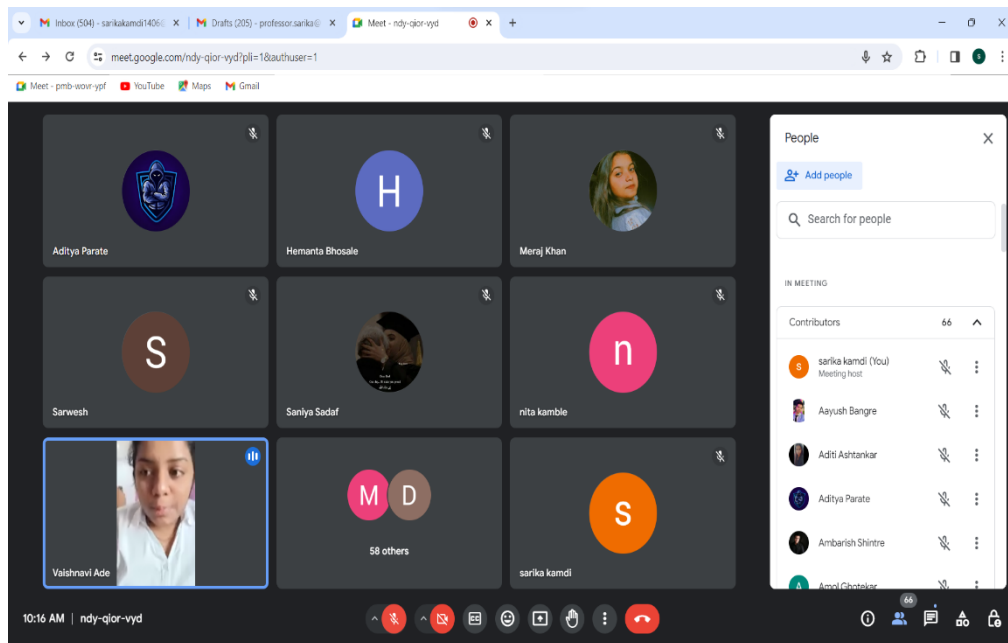
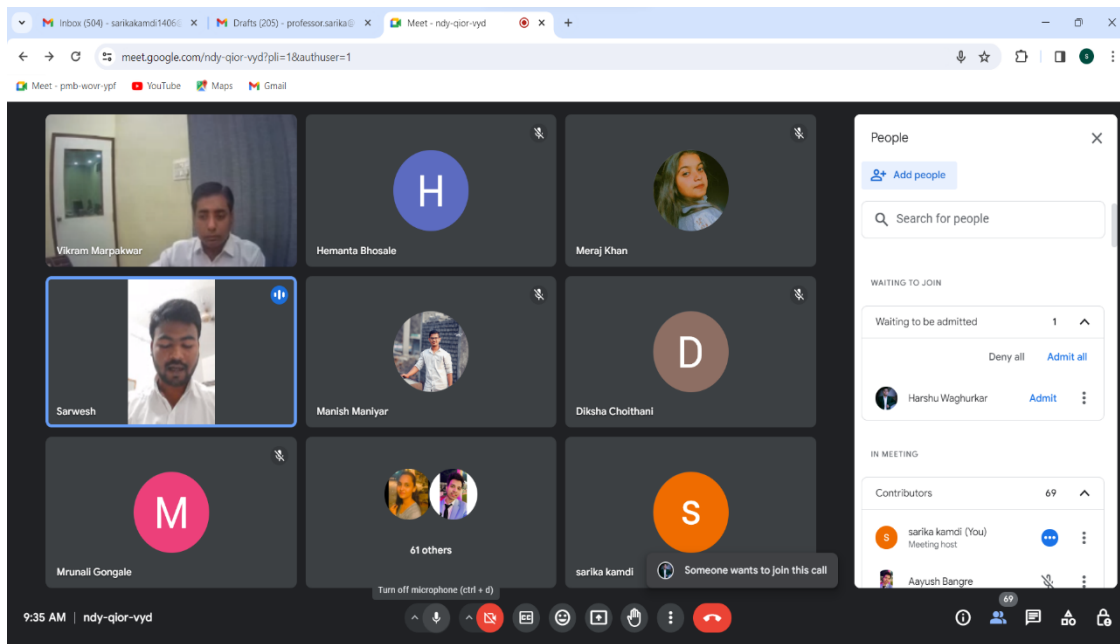
The course content delivered in the lecture is as follows

“MATERNITY BENEFIT ACT”

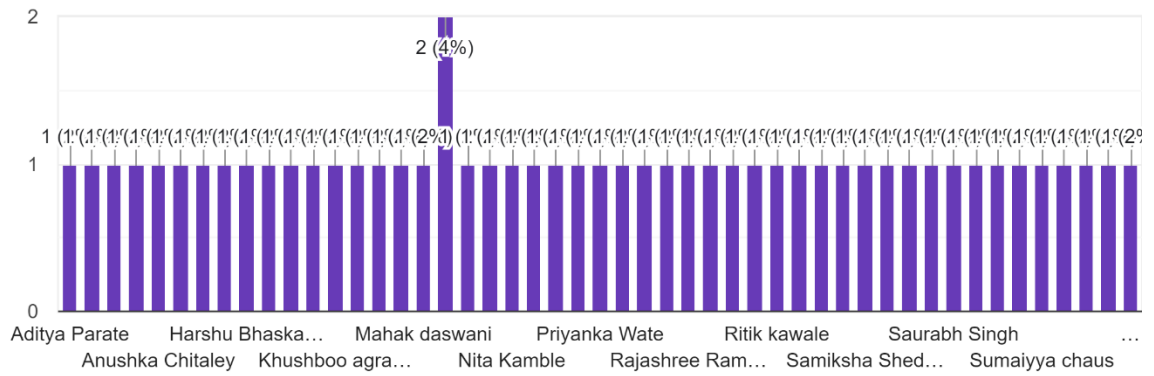

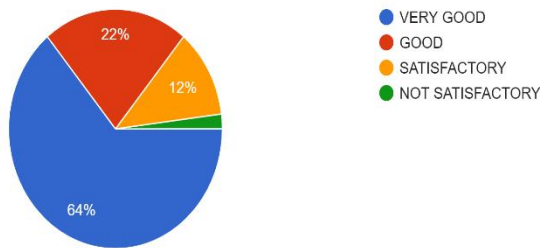

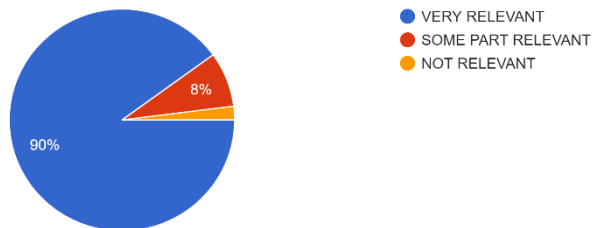
HOW WAS THE LECTURE

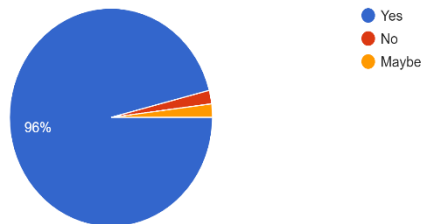
HOW RELEVANT WAS THE CONTENT DISCUSSED BY THE SPEAKER

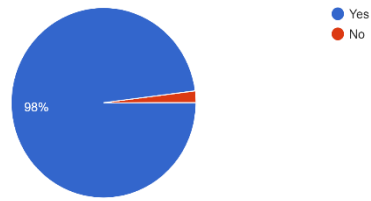
