Criminal Law Club of the Department of Law organized a Guest lecture on the topic "Gender Justice" on 2nd March 2024, Saturday at11.30 am for the students of LLB (3 years) and (5 years). Total 70 students attended the guest lecture. Prof. Dr. Mrs. H.V Menon, the Head of the Department of Law and Dr. Pratima Lokhande were present on the dais. The program commenced with the welcome and introduction of the guest speaker Ms. Mitike Shrivastava, the Research Associate (Law) at Maharashtra National Law University, Nagpur.

Ms. Mitike Shrivastava commenced the session by explaining the concept of Gender justice and explained that Gender justice refers to the fair and equitable treatment of individuals of all genders in social, economic, political, and legal contexts. She highlighted in her lecture that gender equality and gender justice is not limited to difference between men and women, but it also includes the third gender as Transgenders. She explained the discrimination faced by the LGBTQ community by citing various examples and discussed the landmark cases starting from Vishakha vs. State of Rajasthan till the case of Navtej Singh Jauhar.

Ms. Mitike Shrivastava, endeavoured to make student understand the concept of Gender Justice from the international perspective as well where she highlighted that Gender Justice which addresses gender inequalities, is a key to achieving the Millennium Development Goals. Ms. Mitike Shrivastava concluded the session by emphasizing that Gender justice is an important commitment of the Government as enshrined in the Constitution of India and thus sensitized the students into the topic of Gender justice. This was followed by the question answer session in which all the questions were answered by the speaker to the satisfaction of the students.

The Guest lecture was conducted by the student member of Criminal Law Club, Mr. Shardul Polke under the guidance of Dr. Mrs. Vaishali A. Sukhdeve. The Guest lecture on this contemporary topic was arranged by the Criminal Law Club Co-ordinator, Prof. Dr. Sandhya Kalamdhad for the students of law with an intent to sensitize the students about the concept of Gender Justice.
